**STIPULATED SETTLEMENT AND
DISCIPLINARY ORDER**

IT IS HEREBY STIPULATED AND AGREED by and between the parties to the above-entitled proceedings that the following matters are true:

PARTIES

1. William Prasifka (Complainant) is the Executive Director of the Medical Board of California (Board). He brought this action solely in his official capacity and is represented in this matter by Rob Bonta, Attorney General of the State of California, by Veronica Vo, Deputy Attorney General.

1 CULPABILITY

2 9 Respondent agrees that, at an administrative hearing, Complainant could establish a
3 *prima facie* case with respect to the charges and allegations contained in Accusation No. 800-
4 2019-057077 and that he gives up his right to contest the charges and has thereby subjected his
5 Physician's and Surgeon's Certificate to disciplinary action. Respondent further agrees to be
6 bound by the Board's imposition of discipline as set forth in the Disciplinary Order below.

7 10. Respondent further agrees that if he fails to successfully complete the professionalism
8 program, which is more fully described below, within the required time, all of the charges and
9 allegations contained in Accusation No. 800-2019-057077, shall be deemed true, correct, and
10 fully admitted by Respondent for purposes of any further proceeding before the Board, and that
11 his failure to complete the professionalism program shall constitute unprofessional conduct and
12 grounds for further disciplinary action.

13 CONTINGENCY

14 11. This stipulation shall be subject to approval by the Medical Board of California.
15 Respondent understands and agrees that counsel for Complainant and the staff of the Medical
16 Board of California may communicate directly with the Board regarding this stipulation and
17 settlement, without notice to or participation by Respondent or his counsel. By signing the
18 stipulation, Respondent understands and agrees that he may not withdraw his agreement or seek
19 to rescind the stipulation prior to the time the Board considers and acts upon it. If the Board fails
20 to adopt this stipulation as its Decision and Order, the Stipulated Settlement and Disciplinary
21 Order shall be of no force or effect, except for this paragraph, it shall be inadmissible in any legal
22 action between the parties, and the Board shall not be disqualified from further action by having
23 considered this matter.

24 12. The parties understand and agree that Portable Document Format (PDF) and facsimile
25 copies of this Stipulated Settlement and Disciplinary Order, including PDF and facsimile
26 signatures thereto, shall have the same force and effect as the originals.

1 Respondent shall submit a certification of successful completion to the Board or its
2 designee not later than 15 calendar days after successfully completing the program or not later
3 than 15 calendar days after the effective date of the Decision, whichever is later.

4 Any failure by Respondent to comply with the terms and conditions of the Disciplinary
5 Order set forth above shall constitute unprofessional conduct and be grounds for further
6 disciplinary action.

7 ACCEPTANCE

8 I have carefully read the above Stipulated Settlement and Disciplinary Order and have fully
9 discussed it with my attorney, M. Bradley Wishek, Esq.. I understand the stipulation and the
10 effect it will have on my Physician's and Surgeon's Certificate. I enter into this Stipulated
11 Settlement and Disciplinary Order voluntarily, knowingly, and intelligently, and agree to be
12 bound by the Decision and Order of the Medical Board of California.



19 Complainant alleges:

20 **PARTIES**

21 1. William Prasifka (Complainant) brings this Accusation solely in his official capacity
22 as the Executive Director of the Medical Board of California, Department of Consumer Affairs
23 (Board).

24 2. On or about March 22, 2013, the Medical Board issued Physician's and Surgeon's
25 Certificate No. C 55835 to Randall Scott Cohen, M.D. (Respondent). The Physician's and
26 Surgeon's Certificate was in full force and effect at all times relevant to the charges brought
27 herein and will expire on January 31, 2021, unless renewed.

28 ///

1 and the clerk shall record prominently in the file that the defendant holds a license as a physician
2 and surgeon.

3 “(c) The clerk of the court in which a licensee is convicted of a crime shall, within 48 hours
4 after the conviction, transmit a certified copy of the record of conviction to the board. The
5 division may inquire into the circumstances surrounding the commission of a crime in order to fix
6 the degree of discipline or to determine if the conviction is of an offense substantially related to
7 the qualifications, functions, or duties of a physician and surgeon.

8 “(d) A plea or verdict of guilty or a conviction after a plea of nolo contendere is deemed to
9 be a conviction within the meaning of this section and Section 2236.1. The record of conviction
10 shall be conclusive evidence of the fact that the conviction occurred.”

11 7. Section 2239 of the Code states:

12 “(a) The use or prescribing for or administering to himself or herself, of any controlled
13 substance; or the use of any of the dangerous drugs specified in Section 4022, or of alcoholic
14 beverages, to the extent, or in such a manner as to be dangerous or injurious to the licensee, or to
15 any other person or to the public, or to the extent that such use impairs the ability of the licensee
16 to practice medicine safely or more than one misdemeanor or any felony involving the use,
17 consumption, or self-administration of any of the substances referred to in this section, or any
18 combination thereof, constitutes unprofessional conduct. The record of the conviction is
19 conclusive evidence of such unprofessional conduct.

20 “(b) A plea or verdict of guilty or a conviction following a plea of nolo contendere is
21 deemed to be a conviction within the meaning of this section. The Medical Board may order
22 discipline of the licensee in accordance with Section 2227 or the Medical Board may order the
23 denial of the license when the time for appeal has elapsed or the judgment of conviction has been
24 affirmed on appeal or when an order granting probation is made suspending imposition of
25 sentence, irrespective of a subsequent order under the provisions of Section 1203.4 of the Penal
26 Code allowing such person to withdraw his or her plea of guilty and to enter a plea of not guilty,
27 or setting aside the verdict of guilty, or dismissing the accusation, complaint, information, or
28 indictment.”

1 8. California Code of Regulations, title 16, section 1360, states:

2 “For the purposes of denial, suspension or revocation of a license, certificate or permit
3 pursuant to Division 1.5 (commencing with Section 475) of the code, a crime or act shall be
4 considered to be substantially related to the qualifications, functions or duties of a person holding
5 a license, certificate or permit under the Medical Practice Act if to a substantial degree it
6 evidences present or potential unfitness of a person holding a license, certificate or permit to
7 perform the functions authorized by the license, certificate or permit in a manner consistent with
8 the public health, safety or welfare. Such crimes or acts shall include but not be limited to the
9 following: Violating or attempting to violate, directly or indirectly, or assisting in or abetting the
10 violation of, or conspiring to violate any provision of the Medical Practice Act.”

11 **FIRST CAUSE FOR DISCIPLINE**

12 **(Conviction of a Crime Substantially Related to the Qualifications, Functions, or Duties of a**
13 **Physician and Surgeon)**

14 9. Respondent Randall Scott Cohen, M.D. is subject to disciplinary action under
15 sections 2227 and 2234, as defined by section 2236, of the Code, and California Code of
16 Regulations, title 16, section 1360, in that he was convicted of a crime substantially related to the
17 qualifications, functions, or duties of a physician and surgeon. The circumstances are as follows:

18 10. On or about May 30, 2019, Respondent, while on his way to work, was involved in a
19 solo-vehicle accident. Respondent lost control of his vehicle, hit a guardrail, and landed upside
20 down in a creek filled with water. Respondent freed himself from the vehicle and attempted to
21 walk home. While walking, two women noticed Respondent was wet, muddy, and barefoot.
22 These two women drove Respondent home. The two women also reported their observations to
23 law enforcement.

24 Law enforcement arrived at Respondent's home and noticed Respondent exhibited
25 objective signs of intoxication, including; bloodshot, watery eyes, slow, slurred speech, and a
26 strong odor of alcohol. The officer had Respondent perform a variety of field sobriety tests.
27 Respondent staggered as he took these tests. Eventually after failing the field sobriety tests,
28 Respondent was arrested for driving under the influence of alcohol and/or drugs and for leaving

1 the scene of an accident. Shortly thereafter, Respondent agreed to take a breathalyzer test.
2 Respondent's blood alcohol content was 0.18%, over twice the legal limit.

3 11. On June 19, 2019, the Placer County District Attorney filed a criminal complaint
4 against Respondent in the case entitled *The People of the State of California v. Randall Scott*
5 *Cohen*, Placer County Superior Court Case No. 62-167250. Count One of the Complaint charged
6 Respondent with Driving under the Influence of Alcohol, in violation of Vehicle Code section
7 23152, subdivision (a), a misdemeanor. Count Two of the Complaint charged Respondent with
8 driving with a blood alcohol content level of 0.08 percent or more, in violation of Vehicle Code
9 section 23152, subdivision (b), a misdemeanor. In addition, a special allegation was added as to
10 both Counts One and Two, alleging that during the commission of the offenses charged,
11 Respondent drove a vehicle with a blood alcohol content of 0.15 percent or more, within the
12 meaning of Vehicle Code section 23578. Lastly, Count Three of the Complaint charged
13 Respondent with hit and run driving, in violation of Vehicle Code section 20002, subdivision (a),
14 a misdemeanor.

15 12. On or about January 21, 2020, Respondent was convicted upon his plea of no contest
16 to Count Two of the Complaint, i.e., driving with a blood alcohol content level of 0.08 percent or
17 more, in violation of Vehicle Code section 23152, subdivision (b). On the same day of his plea,
18 Respondent was sentenced to the following terms and conditions: 3 years probation, 1 day in jail
19 with credit for time served, 40 hours of community service, DUI panel, 3 month DUI 1st offender
20 program, fine of \$1,538, obey all laws, submit to search and seizure, do not drive with any
21 measurable amount of alcohol/intoxicants in system, do not drive without valid license or
22 insurance, do not refuse to take a chemical test if asked by law enforcement, abstain from the use
23 or possession or intoxicants and do not frequent places where alcohol is the chief item for sale.

24 **SECOND CAUSE FOR DISCIPLINE**

25 **(Use of Alcohol in a Dangerous or Injurious Manner)**

26 13. Respondent is subject to disciplinary action under sections 2227 and 2234, as defined
27 by section 2239, of the Code, and California Code of Regulations, title 16, section 1360, in that
28 he has used alcoholic beverages to the extent, or in such a manner, as to be dangerous or injurious

1 to himself, or to any other person or to the public, as more particularly alleged in paragraphs 9
2 through 12, above, which is hereby incorporated by reference and realleged as if fully set forth
3 herein.

4 **THIRD CAUSE FOR DISCIPLINE**

5 **(Violation of the State Medical Practice Act)**

6 14. Respondent is further subject to disciplinary action under sections 2227 and 2234, as
7 defined by section 2234, subdivision (a), of the Code, and California Code of Regulations, title
8 16, section 1360, in that he has violated a provision or provisions of the Medical Practice Act, as
9 more particularly alleged in paragraphs 9 through 12, above, which are hereby realleged and
10 incorporated by reference as if fully set forth herein.

11 **FOURTH CAUSE FOR DISCIPLINE**

12 **(General Unprofessional Conduct)**

13 15. Respondent is further subject to disciplinary action under sections 2227 and 2234, as
14 defined by section 2234, of the Code, in that he has engaged in conduct which breaches the rules
15 or ethical code of the medical profession, or conduct which is unbecoming a member in good
16 standing of the medical profession, and which demonstrates an unfitness to practice medicine, as
17 more particularly alleged in paragraphs 9 through 12, above, which are hereby realleged and
18 incorporated by reference as if fully set forth herein.


