**AGREEMENT FOR**  
**SURRENDER OF LICENSE**

**TO ALL PARTIES:**

**IT IS HEREBY STIPULATED AND AGREED** by and between the parties to the  
above-entitled proceedings, that the following matters are true:

1. Complainant, William Prasifka, is the Executive Director of the Medical  
Board of California, Department of Consumer Affairs ("Board").

2. Shahper Khalid, M.D. ("Respondent") has carefully read and fully  
understands the effect of this Agreement.

3. Respondent understands that by signing this Agreement she is  
enabling the Board to issue this order accepting the surrender of license without  
further process. Respondent understands and agrees that Board staff and  
counsel for complainant may communicate directly with the Board regarding this  
Agreement, without notice to or participation by Respondent. The Board will not  
be disqualified from further action in this matter by virtue of its consideration of this  
Agreement.

1           4.     Respondent acknowledges there is current disciplinary action against  
2 her license, that on August 31, 2020, a Petition to Revoke Probation was filed  
3 against her and on April 15, 2021, a Decision was rendered wherein her license  
4 was revoked, with the revocation stayed, and placed on probation for three (3)  
5 years to run consecutively from the conclusion of Respondent's probation term in  
6 the Board's Decision in Case No. 800-2014-006120, for a total of nine (9) years'  
7 probation with various standard terms and conditions.

8           5.     The current disciplinary action provides in pertinent part, "Following the  
9 effective date of this Decision, if Respondent ceases practicing due to retirement,  
10 health reasons, or is otherwise unable to satisfy the terms and conditions of  
11 probation, Respondent may request to surrender her license." (Condition #13).

12           6.     Upon acceptance of the Agreement by the Board, Respondent  
13 understands she will no longer be permitted to practice as a physician and  
14 surgeon in California, and also agrees to surrender her wallet certificate, wall  
15 license and any D.E.A. Certificate(s) for an address in California.

16           7.     Respondent fully understands and agrees that if Respondent ever files  
17 an application for relicensure or reinstatement in the State of California, the Board  
18 shall treat it as a Petition for Reinstatement of a revoked license in effect at the  
19 time the Petition is filed. In addition, any Medical Board Investigation Report(s),  
20 including all referenced documents and other exhibits, upon which the Board is  
21 predicated, and any such Investigation Report(s), attachments, and other exhibits,  
22 that may be generated subsequent to the filing of this Agreement for Surrender of  
23 License, shall be admissible as direct evidence, and any time-based defenses,  
24 such as laches or any applicable statute of limitations, shall be waived when the  
25 Board determines whether to grant or deny the Petition.
