19 **YOU ARE HEREBY NOTIFIED** that the Medical Board of California, Department of
20 Consumer Affairs (Board), has automatically revoked Physician's and Surgeon's Certificate No.
21 A157065 by operation of law after having received and reviewed a copy of the record of
22 conviction described below:

23 1. On November 23, 2021, in a criminal proceeding entitled *The People of the State*
24 *of California v. Dylan Edward O'Connor*, in the San Mateo County Superior Court (Court), Case
25 Number 21-SF-002211-A, Dylan Edward O'Conner was convicted for violating California Penal
26 Code section 288.2 (a)(2), a felony (Distributing or Showing Pornography to a Minor).

1 Specifically, Dylan Edward O'Conner sent explicit photos and videos of himself to a sixteen-
2 year-old and asked the minor to send explicit photographs of herself to Respondent.

3 2. On April 13, 2022, Respondent was sentenced to three years' prison time (sentence
4 suspended) and one year of county jail to be followed by two years of supervised probation. The
5 Court further required Dylan Edward O'Conner to register as a sex offender pursuant to
6 California Penal Code section 290.

7 3. Attached hereto and incorporated by reference are documents from Case No 21-SF-
8 002211-A supporting these findings:

12 **SEX OFFENDER REGISTRATION: AUTOMATIC REVOCATION**

13 5. Section 2232 of the Code states in pertinent part:

14 "(a) Except as provided in subdivisions (c), (d), and (e), the board shall automatically
15 revoke the license of any person who, at any time after January 1, 1947, has been required to
16 register as a sex offender pursuant to the provisions of Section 290 of the Penal Code, regardless
17 of whether the related conviction has been appealed. The board shall notify the licensee of the
18 license revocation and of his or her right to elect to have a hearing as provided in subdivision (b).


19 "(b) Upon revocation of the physician's and surgeon's certificate, the holder of the
20 certificate may request a hearing within 30 days of the revocation. The proceeding shall be
21 conducted in accordance with the Administrative Procedure Act (Chapter 5 (commencing with
22 Section 11500) of Part I of Division 3 of Title 2 of the Government Code)."

23 **WHEREFORE, THE MEDICAL BOARD OF CALIFORNIA, DEPARTMENT OF**
24 **CONSUMER AFFAIRS, HEREBY NOTIFIES YOU THAT,** by virtue of said conviction and
25 requirement to register as a sex offender, Physician's and Surgeon's Certificate No. A157065,
26 issued to Dylan Edward O'Conner, M.D. is automatically revoked by operation law, effective
27 May 26, 2022, pursuant to Business and Professions Code section 2232. You shall cause to be
28

1 delivered to the Board both your wall and pocket license certificate within 15 days from the date
2 of the service of this Order.

3 **YOU ARE FURTHER NOTIFIED THAT** you have a right to a hearing as provided by
4 Business and Professions Code section 2232, subdivision (b), as set forth above. A request for a
5 hearing may be made by delivering or mailing such a request to: Carolyn Evans, Deputy
6 Attorney General, Department of Justice, Office of the Attorney General, 455 Golden Gate
7 Avenue, Suite 11000, San Francisco, CA 94102. This Notice is being served by a designee of the

7 EDWARD OCONNOR did unlawfully and motivated by an unnatural and abnormal sexual interest
8 in children, arrange a meeting with JANE DOE, a person defendant, DYLAN EDWARD
9 OCONNOR believed to be a minor, for the purpose of exposing the genitals and pubic and rectal area
10 of JANE DOE and defendant, DYLAN EDWARD OCONNOR, and to engage in lewd and lascivious
11 behavior, and did go to the arranged meeting place at and about the arranged time. NOTICE:
12 Conviction of this offense will require you to register pursuant to Penal Code section 290. Willful
13 failure to register is a crime.

15 COUNT 3: PC664/PC311.4(c) (Felony)

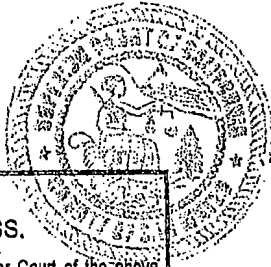
