REVOCATION OF LICENSE**

19 TO RESPONDENT ANGEL V. ARAFILES, JR., M.D.:

20 **YOU ARE HEREBY NOTIFIED THAT** the Medical Board of California (Board), has
21 automatically revoked Physician's and Surgeon's Certificate No. C 43233 by operation of law
22 after having received and reviewed a certified copy of the record of conviction described below:

23 1. The Board received notice of Respondent Angel V. Arafiles, Jr., M.D.'s (Respondent)
24 conviction and sentencing in *People of the State of California v. Angel Vidal Arafiles, Jr.*,
25 Superior Court of the State of California, County of Los Angeles, case no. BA482974. These
26 documents establish that on June 6, 2022, after a plea of nolo contendere, Respondent was found
27 guilty of committing felonies as follows: violations of Penal Code section 288(a), lewd act upon a
28 child under the age of 14.

1 2. On or about August 15, 2022, Respondent was sentenced to register as a convicted
2 sex offender, pursuant to Penal Code section 290 and carry proof of registration at all times.
3 Respondent was also sentenced to serve 3 years in state prison as to Count 3 and to serve 2 years
4 in state prison as to Count 4. The sentence in Court 4 is to run consecutive to the sentence in
5 Count 3, for a total of 5 years. Respondent was sentenced to other terms and conditions,
6 including that he pay victim restitution and submit to an AIDS test, pursuant to Penal Code
7 section 1202.1.

8 3. The following documents supports these findings, and are attached and incorporated
9 herein by reference:

10 Attachment A: Copy of Criminal Complaint

11 Attachment B: Certified Copy of Criminal Docket re: Sentencing

12 **REGISTERED SEX OFFENDER: AUTOMATIC REVOCATION**

13 4. Business and Professions Code section 2232, states:

14 (a) Except as provided in subdivisions (c), (d), and (e), the board shall
15 automatically revoke the license of any person who, at any time after January 1, 1947,
16 has been required to register as a sex offender pursuant to the provisions of Section
17 290 of the Penal Code, regardless of whether the related conviction has been
18 appealed. The board shall notify the licensee of the license revocation and of his or
19 her right to elect to have a hearing as provided in subdivision (b).

20 (b) Upon revocation of the physician's and surgeon's certificate, the
21 holder of the certificate may request a hearing within 30 days of the revocation. The
22 proceeding shall be conducted in accordance with the Administrative Procedure Act
23 (Chapter 5 (commencing with Section 11500) of Part 1 of Division 3 of Title 2 of the
24 Government Code).

25 (c) This section shall not apply to a person who is required to register as a
26 sex offender pursuant to Section 290 of the Penal Code solely because of a
27 misdemeanor conviction under Section 314 of the Penal Code.

28 (d)(1) Five years after the effective date of the revocation and three years
after successful discharge from parole, probation, or both parole and probation if
under simultaneous supervision, an individual who after January 1, 1947, and prior to
January 1, 2005, was subject to subdivision (a), may petition the superior court, in the
county in which the individual has resided for, at minimum, five years prior to filing
the petition, to hold a hearing within one year of the date of the petition, in order for
the court to determine whether the individual no longer poses a possible risk to
patients. The individual shall provide notice of the petition to the Attorney General
and to the board at the time of its filing. The Attorney General and the board shall
present written and oral argument to the court on the merits of the petition.

(2) If the court finds that the individual no longer poses a possible risk to

1 patients, and there are no other underlying reasons for which the board pursued
2 disciplinary action, the court shall order, in writing, the board to reinstate the
3 individual's license within 180 days of the date of the order. The board may issue a
4 probationary license to a person subject to this paragraph subject to terms and
5 conditions, including, but not limited to, any of the conditions of probation specified
6 in Section 2221.

7 (3) If the court finds that the individual continues to pose a possible risk
8 to patients, the court shall deny relief. The court's decision shall be binding on the
9 individual and the board, and the individual shall be prohibited from filing a
10 subsequent petition under this section based on the same conviction.

11 (e) This section shall not apply to a person who has been relieved under
12 Section 290.5 of the Penal Code of his or her duty to register as a sex offender, or
13 whose duty to register has otherwise been formally terminated under California law.

14 (f) If the related conviction of the certificate holder is overturned on
15 appeal, the revocation ordered pursuant to this section shall automatically cease.
16 Nothing in this subdivision shall prohibit the board from pursuing disciplinary action
17 based on any cause other than the overturned conviction.

18 (g) The other provisions of this article setting forth a procedure for the
19 revocation of a physician's and surgeon's certificate shall not apply to proceedings
20 conducted pursuant to this section.

21 **WHEREFORE, THE MEDICAL BOARD OF CALIFORNIA, DEPARTMENT OF**
22 **CONSUMER AFFAIRS, HEREBY NOTIFIES YOU THAT**, by virtue of said conviction,
23 Physician's and Surgeon's Certificate No. C 43233, issued to Angel V. Arafiles, Jr., M.D., is
24 automatically revoked by operation law, effective August 15, 2022, pursuant to Business and
25 Professions Code section 2232, subdivision (a).

26 Said automatic revocation shall continue thereafter until a hearing may be held pursuant to
27 Business and Professions Code section 2232, subdivision (b), or until further order of the Board.

28 Angel V. Arafiles, Jr., must cause to be delivered to the Board both his wall and pocket
license certificate within 15 days from the date of the service of this Order.





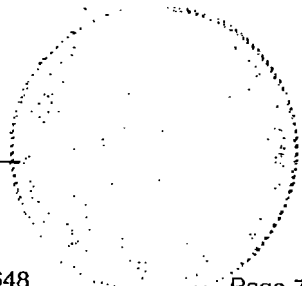
