**STIPULATED SURRENDER OF
LICENSE AND ORDER**

25 IT IS HEREBY STIPULATED AND AGREED by and between the parties to the above-
26 entitled proceedings that the following matters are true:

27 **PARTIES**

28 1. William Prasifka (Complainant) is the Executive Director of the Medical Board of
California (Board). He brought this action solely in his official capacity and is represented in this
matter by Rob Bonta, Attorney General of the State of California, by Greg W. Chambers,
Supervising Deputy Attorney General.

2. Sheldon Earl Gingerich, M.D. (Respondent) is represented in this proceeding by
attorney Susan Brichler Trujillo, whose address is: Quarles & Brady LLP, One Renaissance
Square, Two North Central Avenue, Suite 600, Phoenix, AZ 85004-2322.

1 surrenders his Physician's and Surgeon's Certificate No. G 53642 for the Board's formal
2 acceptance.

3 9. Respondent understands that by signing this stipulation he enables the Board to issue
4 an order accepting the surrender of his Physician's and Surgeon's Certificate without further
5 process.

6 CONTINGENCY

7 10. This stipulation shall be subject to approval by the Board. Respondent understands
8 and agrees that counsel for Complainant and the staff of the Board may communicate directly
9 with the Board regarding this stipulation and surrender, without notice to or participation by
10 Respondent or his counsel. By signing the stipulation, Respondent understands and agrees that he
11 may not withdraw his agreement or seek to rescind the stipulation prior to the time the Board
12 considers and acts upon it. If the Board fails to adopt this stipulation as its Decision and Order,
13 the Stipulated Surrender and Disciplinary Order shall be of no force or effect, except for this
14 paragraph, it shall be inadmissible in any legal action between the parties, and the Board shall not
15 be disqualified from further action by having considered this matter.

16 11. The parties understand and agree that Portable Document Format (PDF) and facsimile
17 copies of this Stipulated Surrender of License and Order, including PDF and facsimile signatures
18 thereto, shall have the same force and effect as the originals.

19 12. In consideration of the foregoing admissions and stipulations, the parties agree that
20 the Board may, without further notice or formal proceeding, issue and enter the following Order:

21 ORDER

22 IT IS HEREBY ORDERED that Physician's and Surgeon's Certificate No. G 53642, issued
23 to Respondent Sheldon Earl Gingerich, M.D., is surrendered and accepted by the Board.

24 1. The surrender of Respondent's Physician's and Surgeon's Certificate and the
25 acceptance of the surrendered license by the Board shall constitute the imposition of discipline
26 against Respondent. This stipulation constitutes a record of the discipline and shall become a part
27 of Respondent's license history with the Board.

2. Respondent shall lose all rights and privileges as a physician and surgeon in California as of the effective date of the Board's Decision and Order.

3. Respondent shall cause to be delivered to the Board his pocket license and, if one was issued, his wall certificate on or before the effective date of the Decision and Order.

4. If he ever applies for licensure or petitions for reinstatement in the State of California, the Board shall treat it as a petition for reinstatement of a revoked certificate in effect at the time the petition is filed. Respondent must comply with all the laws, regulations and procedures for licensure in effect at the time the application or petition is filed, and all of the charges and allegations contained in First Amended Accusation No. 800-2019-060929 shall be deemed to be true, correct and admitted by Respondent when the Board determines whether to grant or deny the application or petition.

5. If Respondent should ever apply or reapply for a new license or certification, or petition for reinstatement of a license, by any other health care licensing agency in the State of California, all of the charges and allegations contained in First Amended Accusation, No. 800-2019-060929 shall be deemed to be true, correct, and admitted by Respondent for the purpose of any Statement of Issues or any other proceeding seeking to deny or restrict licensure.

ACCEPTANCE

I have carefully read the above Stipulated Surrender of License and Order in its entirety. I fully understand the stipulation and the effect it will have on my Physician's and Surgeon's Certificate. I enter into this Stipulated Surrender of License and Order voluntarily, knowingly, and intelligently, and agree to be bound by the Decision and Order of the Medical Board of California.

FIRST AMENDED ACCUSATION

14 **Physician's and Surgeon's Certificate**
15 **No. G 53642,**

16 Respondent.

17
18 **PARTIES**

19 1. William Prasifka (Complainant) brings this First Amended Accusation solely in his
20 official capacity as the Interim Executive Director of the Medical Board of California,
21 Department of Consumer Affairs (Board).

22 2. On or about September 24, 1984, the Medical Board issued Physician's and Surgeon's
23 Certificate Number G 53642 to Sheldon Earl Gingerich, M.D. (Respondent). The Physician's and
24 Surgeon's Certificate expired on June 30, 2020, without being renewed.

25 **JURISDICTION**

26 3. This First Amended Accusation is brought before the Board, under the authority of
27 the following laws. All section references are to the Business and Professions Code (Code)
28 unless otherwise indicated.

1 4. Section 2004 of the Code provides that the Board shall have the responsibility for the
2 enforcement of the disciplinary and criminal provisions of the Medical Practice Act.

3 5. Section 2227 of the Code provides that a licensee who is found guilty under the
4 Medical Practice Act may have his or her license revoked, suspended for a period not to exceed
5 one year, placed on probation and required to pay the costs of probation monitoring, or such other
6 action taken in relation to discipline as the Board deems proper.

7 6. Section 2305 of the Code states:

8 “The revocation, suspension, or other discipline, restriction or limitation imposed by
9 another state upon a license or certificate to practice medicine issued by that state, or the
10 revocation, suspension, or restriction of the authority to practice medicine by any agency of the
11 federal government, that would have been grounds for discipline in California of a licensee under
12 this chapter shall constitute grounds for disciplinary action for unprofessional conduct against the
13 licensee in this state.”

14 7. Section 2236 of the Code states:

15 (a) The conviction of any offense substantially related to the qualifications, functions, or
16 duties of a physician and surgeon constitutes unprofessional conduct within the meaning of this
17 chapter [Chapter 5, the Medical Practice Act]. The record of conviction shall be conclusive
18 evidence only of the fact that the conviction occurred.

19 (b) The district attorney, city attorney, or other prosecuting agency shall notify the Medical
20 Board of the pendency of an action against a licensee charging a felony or misdemeanor
21 immediately upon obtaining information that the defendant is a licensee. The notice shall identify
22 the licensee and describe the crimes charged and the facts alleged. The prosecuting agency shall
23 also notify the clerk of the court in which the action is pending that the defendant is a licensee,
24 and the clerk shall record prominently in the file that the defendant holds a license as a physician
25 and surgeon.

26 (c) The clerk of the court in which a licensee is convicted of a crime shall, within 48 hours
27 after the conviction, transmit a certified copy of the record of conviction to the board. The
28 division may inquire into the circumstances surrounding the commission of a crime in order to fix

1 the degree of discipline or to determine if the conviction is of an offense substantially related to
2 the qualifications, functions, or duties of a physician and surgeon.

3 (d) A plea or verdict of guilty or a conviction after a plea of nolo contendere is deemed to
4 be a conviction within the meaning of this section and Section 2236.1. The record of conviction
5 shall be conclusive evidence of the fact that the conviction occurred.

6 8. Section 2237 of the Code states:

7 (a) The conviction of a charge of violating any federal statutes or regulations or any statute
8 or regulation of this state, regulating dangerous drugs or controlled substances, constitutes
9 unprofessional conduct. The record of the conviction is conclusive evidence of such
10 unprofessional conduct. A plea or verdict of guilty or a conviction following a plea of nolo
11 contendere is deemed to be a conviction within the meaning of this section.

12 (b) Discipline may be ordered in accordance with Section 2227 or the Medical Board may
13 order the denial of the license when the time for appeal has elapsed, or the judgment of conviction
14 has been affirmed on appeal, or when an order granting probation is made suspending the
15 imposition of sentence, irrespective of a subsequent order under the provisions of Section 1203.4
16 of the Penal Code allowing such person to withdraw his or her plea of guilty and to enter a plea of
17 not guilty, or setting aside the verdict of guilty, or dismissing the accusation, complaint,
18 information, or indictment.

19 9. Section 2238 of the Code states:

20 A violation of any federal statute or federal regulation or any of the statutes or regulations
21 of this state regulating dangerous drugs or controlled substances constitutes unprofessional
22 conduct.

23 10. California Code of Regulations, title 16, section 1360, states:

24 "For the purposes of denial, suspension or revocation of a license, certificate or permit
25 pursuant to Division 1.5 (commencing with Section 475) of the code, a crime or act shall be
26 considered to be substantially related to the qualifications, functions or duties of a person holding
27 a license, certificate or permit under the Medical Practice Act if to a substantial degree it
28 evidences present or potential unfitness of a person holding a license, certificate or permit to

1 perform the functions authorized by the license, certificate or permit in a manner consistent with
2 the public health, safety or welfare. Such crimes or acts shall include but not be limited to the
3 following: Violating or attempting to violate, directly or indirectly, or assisting in or abetting the
4 violation of, or conspiring to violate any provision of the Medical Practice Act.”

5 **CAUSE FOR DISCIPLINE**

6 **(Unprofessional Conduct: Conviction)**

7 11. Respondent Sheldon Earl Gingerich, M.D. is subject to disciplinary action under
8 sections 2234 [unprofessional conduct] and 2236 [conviction] and 2237 [conviction], and 2238
9 [violation of federal statute] of the Code and California Code of Regulations, title 16, section
10 1360 [criminal conviction], in that on or about November 1, 2022, Respondent voluntarily
11 entered into a plea agreement with the United States Government in *United States of America v.*
12 *Sheldon Gingerich*, United States District Court for the District of Arizona, Case No. CR20-
13 02703-TUC-RCC, pleading guilty to the federal misdemeanor offenses of 21 U.S.C. section 844
14 and 18 U.S.C. section 2, aiding and abetting simple possession of a controlled substance, in this
15 case fentanyl.

16 12. On November 1, 2022, Respondent was sentenced to two years' probation and fined
17 \$75,000.

18 13. Respondent engaged in unprofessional conduct, pursuant to section 2234 of the Code,
19 by virtue of the fact that Respondent aided and abetted simple possession of a controlled
20 substance – fentanyl – in contravention to federal law, which constitutes unprofessional conduct
21 and cause for discipline pursuant to sections 2234, 2236, 2237, and 2238 of the Code, and title 16,
22 section 1360 of the California Code of Regulations.


23 **PRAYER**

24 WHEREFORE, Complainant requests that a hearing be held on the matters herein alleged,
25 and that following the hearing, the Medical Board of California issue a decision:

26 1. Revoking or suspending Physician's and Surgeon's Certificate Number G 53642,
27 issued to Sheldon Earl Gingerich, M.D.;

- 1 2. Revoking, suspending or denying approval of Sheldon Earl Gingerich, M.D.'s
2 authority to supervise physician assistants and advanced practice nurses;
3 3. Ordering Sheldon Earl Gingerich, M.D., if placed on probation, to pay the Board the
4 costs of probation monitoring; and
5 4. Taking such other and further action as deemed necessary and proper.
