**AGREEMENT FOR
SURRENDER OF LICENSE**

TO ALL PARTIES:

IT IS HEREBY STIPULATED AND AGREED by and between the parties to the above-entitled proceedings, that the following matters are true:

1. Complainant, Reji Varghese, is the Interim Executive Director of the Medical Board of California, Department of Consumer Affairs ("Board").
2. Michael E. Balkovich, M.D. ("Respondent") has carefully read and fully understands the effect of this Agreement.
3. Respondent understands that by signing this Agreement he is enabling the Board to issue this order accepting the surrender of license without further process. Respondent understands and agrees that Board staff and counsel for complainant may communicate directly with the Board regarding this Agreement, without notice to or participation by Respondent. The Board will not be disqualified from further action in this matter by virtue of its consideration of this Agreement.
4. Respondent acknowledges there is current disciplinary action against his license, that on February 10, 1983, an Accusation was filed against him and on March 16, 1984, a Decision was rendered wherein his license was revoked, with

the revocation stayed, and placed on seven years' probation with various standard terms and conditions.

2 5. Upon acceptance of the Agreement by the Board, Respondent
3 understands he will no longer be permitted to practice as a physician and surgeon
4 in California, and also agrees to surrender his wallet certificate, wall license and
5 any D.E.A. Certificate(s) for an address in California.

6 6. Respondent fully understands and agrees that if Respondent ever files
7 an application for relicensure or reinstatement in the State of California, the Board
8 shall treat it as a Petition for Reinstatement of a revoked license in effect at the
9 time the Petition is filed. In addition, any Medical Board Investigation Report(s),
10 including all referenced documents and other exhibits, upon which the Board is
11 predicated, and any such Investigation Report(s), attachments, and other exhibits,
12 that may be generated subsequent to the filing of this Agreement for Surrender of
13 License, shall be admissible as direct evidence, and any time-based defenses,
14 such as laches or any applicable statute of limitations, shall be waived when the
15 Board determines whether to grant or deny the Petition.

ACCEPTANCE


