Public Letter of Reprimand

Pursuant to the provisions of California Business and Professions Code section 2221.05, the Medical Board of California (Board) hereby issues you this Public Letter of Reprimand (PLR).

The Board received information from the West Virginia Board of Medicine that on April 24, 2020, they entered into a Consent Order with you for treating patients via telemedicine without first establishing a physician-patient relationship. Currently, you hold an active medical license in the state of West Virginia, which will expire on June 30, 2025, if not renewed. A copy of the West Virginia Board of Medicine's Consent Order is attached hereto as Exhibit A.

The Board received information from the Tennessee Board of Medical Examiners that on September 30, 2020, they entered into a Consent Order with you for failure to report the West Virginia Board of Medicine's disciplinary action within thirty (30) days of the action. Currently, you hold an active medical license in the state of Tennessee, which will expire on January 31, 2025, if not renewed. A copy of the Tennessee Board of Medical Examiner's Consent Order is attached hereto as Exhibit B.

The Board received information from the North Carolina Medical Board that on October 2, 2020, they entered into a Consent Order with you based upon your prior disciplinary action by the West Virginia Board of Medicine. Currently, you hold an active medical license in the state of North Carolina, which will expire on January 9, 2024, if not renewed. A copy of the North Carolina Medical Board's Consent Order is attached hereto as Exhibit C.

The Board received information from the Florida Board of Medicine that on November 9, 2020, an Administrative Complaint was filed based upon your prior disciplinary action by the West Virginia Board of Medicine. The Board received information from the Florida Board of Medicine that on May 20, 2021, they entered into a Settlement Agreement with you based upon your prior disciplinary action by the West Virginia Board of Medicine. Currently you hold an active medical in the state of Florida, which will expire on January 31, 2024, if not renewed. A copy of the Florida Board of Medicine's Settlement Agreement is attached hereto as Exhibit D.

The Board received information from the Illinois State Medical Board that on April 19, 2021, they entered into a Consent Order with you based upon your prior disciplinary action by the West Virginia Board of Medicine. Currently you hold an active medical license in the state of

Illinois, which will expire on July 31, 2026, if not renewed. A copy of the Illinois State Medical Board's Consent Order is attached hereto as Exhibit E.

The Board received information from the Oregon Medical Board that on April 25, 2022, a Complaint and Notice of Proposed Disciplinary Action was filed based upon your prior disciplinary action by the North Carolina Medical Board, Tennessee Board of Medical Examiners, Illinois State Medical Board, and Florida Board of Medicine, and your failure to disclose those actions. The Board received information from the Oregon Medical Board that on July 7, 2022, they entered into Stipulated Order with you based upon the conduct in the Complaint and Notice of Proposed Disciplinary Action. Currently you hold an active medical license in the state of Oregon, which will expire on December 31, 2023, if not renewed. A copy of the Oregon Medical Board's Stipulated Order is attached hereto as Exhibit F.

The conduct and disciplinary actions described above constitute grounds for issuance of this PLR under Business and Professions Code sections 480(a)(2) and 2234.
