DEFAULT DECISION
AND ORDER

[Gov. Code, §11520]

20 **FINDINGS OF FACT**

21 1. On or about January 6, 2023, Complainant Reji Varghese, in his official capacity as
22 the Executive Director of the Medical Board of California, Department of Consumer Affairs, filed
23 Petition to Revoke Probation No. 800-2022-089754 against DONALD DALE DAVIDSON, M.D.
24 (Respondent) before the Medical Board of California.

25 2. On or about June 18, 2015, the Medical Board of California (Board) issued
26 Physician's and Surgeon's Certificate No. A 137144 to Respondent. The Physician's and
27 Surgeon's Certificate was in full force and effect at all times relevant to the charges brought
28

1 herein and expired on November 30, 2022. A copy of the Certificate of Licensure is attached as
2 **Exhibit A.**

3 3. On or about January 6, 2023, Andrea Geremia, an employee of the Complainant
4 Agency, served by Certified Mail a copy of the Petition to Revoke Probation No. 800-2022-
5 089754, Statement to Respondent, Notice of Defense, Request for Discovery, and Government
6 Code sections 11507.5, 11507.6, and 11507.7 to Respondent's address of record with the Board,
7 which was and is 5011 University Center Drive, Suite 22B, Las Vegas, NV 89119-1394. A copy
8 of the Petition to Revoke Probation, the related documents, and Declaration of Service are
9 attached as **Exhibit B**, and are incorporated herein by reference.

10 4. Service of the Petition to Revoke Probation was effective as a matter of law under the
11 provisions of Government Code section 11505, subdivision (c).

12 5. On or about February 12, 2023, Respondent signed and returned a Notice of Defense,
13 requesting a hearing in this matter. A Notice of Hearing was served by mail at Respondent's
14 address of record and it informed him that an administrative hearing in this matter was scheduled
15 for August 28, 2023. Respondent failed to appear at that hearing. A copy of Respondent's Notice
16 of Defense, the Notice of Hearing, and Declaration of Service are attached hereto as **Exhibit C**,
17 and are incorporated herein by reference.

18 6. **Exhibit D** contains a Declaration from the Management Services Technician
19 declaring that Respondent violated his probation and remains in non-compliance with his
20 probation.

21 7. Government Code section 11506 states, in pertinent part:

22 (c) The respondent shall be entitled to a hearing on the merits if the respondent
23 files a notice of defense, and the notice shall be deemed a specific denial of all parts
24 of the accusation not expressly admitted. Failure to file a notice of defense shall
constitute a waiver of respondent's right to a hearing, but the agency in its discretion
may nevertheless grant a hearing.

25 8. California Government Code section 11520 states, in pertinent part:

26 (a) If the respondent either fails to file a notice of defense or to appear at the
27 hearing, the agency may take action based upon the respondent's express admissions
28 or upon other evidence and affidavits may be used as evidence without any notice to
respondent.

1 9. Pursuant to its authority under Government Code section 11520, the Board finds
2 Respondent is in default. The Board will take action without further hearing and, based on
3 Respondent's express admissions by way of default and the evidence before it, contained in
4 exhibits A, B, C and D, finds that the allegations in Petition to Revoke Probation No. 800-2022-
5 089754 are true.

6 **DETERMINATION OF ISSUES**

7 1. Based on the foregoing findings of fact, Respondent Donald Dale Davidson, M.D. has
8 subjected his Physician's and Surgeon's Certificate No. A 137144 to discipline.

9 2. A copy of the Petition to Revoke Probation and the related documents and
10 Declaration of Service are attached hereto as Exhibit B.

11 3. The agency has jurisdiction to adjudicate this case by default.

12 4. The Medical Board of California is authorized to revoke Respondent's Physician's and
13 Surgeon's Certificate based upon the following violations alleged in the Petition to Revoke
14 Probation:

15 a. Failure to comply with Probation Condition 9, Quarterly Declarations;

16 b. Failure to comply with Probation Condition 10, General Probation
17 Requirements (Travel or Residence Outside California);

18 c. Failure to comply with Probation Condition 12, Non-Practice While on
19 Probation; and

20 d. Failure to comply with Probation Condition 14, Violation of Probation.

21 5. The foregoing violations are supported by the Declaration of Christina Valencia,
22 Management Services Technician (see **Exhibit D**).

20 **PARTIES**

21 1. Reji Varghese (Complainant) brings this Petition to Revoke Probation solely in his
22 official capacity as the Deputy Director of the Medical Board of California, Department of
23 Consumer Affairs (Board).

24 2. On or about June 18, 2015, the Medical Board of California issued Physician's and
25 Surgeon's Certificate Number A 137144 to Donald Dale Davidson, M.D. (Respondent). The
26 Physician's and Surgeon's Certificate was in effect at all times relevant to the charges brought
27 herein and expired on November 30, 2022.

28 ///

1 3. In a disciplinary action titled "In the Matter of First Amended Accusation Against
2 Donald Dale Davidson, M.D.," Case No. 800-2017-030039, the Medical Board of California,
3 issued a decision, effective January 10, 2020, in which Respondent's Physician's and Surgeon's
4 Certificate was revoked. However, the revocation was stayed and Respondent's Physician's and
5 Surgeon's Certificate was placed on probation for a period of three (3) years with certain terms
6 and conditions. A copy of that decision is attached as Exhibit A and is incorporated by reference.

7
JURISDICTION

8 4. This Petition to Revoke Probation is brought before the Board under the authority of
9 the following laws. All section references are to the Business and Professions Code unless
10 otherwise indicated.

11 5. Section 118 of the Code states:

12 (a) The withdrawal of an application for a license after it has been filed with a
13 board in the department shall not, unless the board has consented in writing to such
14 withdrawal, deprive the board of its authority to institute or continue a proceeding
15 against the applicant for the denial of the license upon any ground provided by law or
16 to enter an order denying the license upon any such ground.

17 (b) The suspension, expiration, or forfeiture by operation of law of a license
18 issued by a board in the department, or its suspension, forfeiture, or cancellation by
19 order of the board or by order of a court of law, or its surrender without the written
20 consent of the board, shall not, during any period in which it may be renewed,
21 restored, reissued, or reinstated, deprive the board of its authority to institute or
22 continue a disciplinary proceeding against the licensee upon any ground provided by
23 law or to enter an order suspending or revoking the license or otherwise taking
24 disciplinary action against the licensee on any such ground.

25 (c) As used in this section, "board" includes an individual who is authorized by
26 any provision of this code to issue, suspend, or revoke a license, and "license"
27 includes "certificate," "registration," and "permit."

28 6. Section 2227 of the Code states:

(a) A licensee whose matter has been heard by an administrative law judge of
the Medical Quality Hearing Panel as designated in Section 11371 of the Government
Code, or whose default has been entered, and who is found guilty, or who has entered
into a stipulation for disciplinary action with the board, may, in accordance with the
provisions of this chapter:

(1) Have his or her license revoked upon order of the board.

(2) Have his or her right to practice suspended for a period not to exceed one
year upon order of the board.

1 (3) Be placed on probation and be required to pay the costs of probation
monitoring upon order of the board.

2 (4) Be publicly reprimanded by the board. The public reprimand may include a
3 requirement that the licensee complete relevant educational courses approved by the
board.

4 (5) Have any other action taken in relation to discipline as part of an order of
5 probation, as the board or an administrative law judge may deem proper.

6 (b) Any matter heard pursuant to subdivision (a), except for warning letters,
7 medical review or advisory conferences, professional competency examinations,
8 continuing education activities, and cost reimbursement associated therewith that are
9 agreed to with the board and successfully completed by the licensee, or other matters
made confidential or privileged by existing law, is deemed public, and shall be made
available to the public by the board pursuant to Section 803.1.

10 **FIRST CAUSE TO REVOKE PROBATION**

11 (Quarterly Declarations)

12 7. At all times after the effective date of Respondent's probation, Condition 9, Quarterly
13 Declarations, states:

14 Respondent shall submit quarterly declarations under penalty of perjury on
15 forms provided by the Board, stating whether there has been compliance with all the
conditions of probation.

16 Respondent shall submit quarterly declarations not later than 10 calendar days
17 after the end of the preceding quarter.

18 8. Respondent's probation is subject to revocation because he failed to comply with
19 Probation Condition 9, referenced above. The facts and circumstances regarding this violation
20 are as follows:

21 A. On or about April 10, 2020, July 24, 2020, October 10, 2020, January 18, 2021, and
22 May 14, 2021, the Board received quarterly declarations from Respondent. The Board has not
23 received any additional quarterly declarations.

24 B. On or about July 23, 2020, April 30, 2021, April 13, 2022, Respondent was issued
25 non-compliance letters indicating that the Board had not received the necessary quarterly
26 declarations and he needed to submit them or provide proof of compliance.

27 ///

28 ///

1 **SECOND CAUSE TO REVOKE PROBATION**

2 (General Probation Requirements (Travel or Residence Outside California))

3 9. At all times after the effective date of Respondent's probation, Condition 10, General
4 Probation Requirements, states, in pertinent part:

5 Travel or Residence Outside California. Respondent shall immediately inform
6 the Board or its designee, in writing, of travel to any areas outside the jurisdiction of
California which lasts, or is contemplated to last, more than thirty (30) calendar days.

7 In the event Respondent should leave the State of California to reside or to
8 practice, Respondent shall notify the Board or its designee in writing 30 days prior to
the dates of departure and return.

9
10 10. Respondent's probation is subject to revocation because he failed to comply with
11 Probation Condition 10, referenced above. The facts and circumstances regarding this violation
12 are as follows:

13 A. Respondent resided in Nevada on the effective date of Decision No. 800-2017-
14 030039, January 10, 2020. On or about September 15, 2021, Respondent informed the Board that
15 he returned to California. However, Respondent failed to submit prior written notification of his
16 return to California, and failed to update his address with the Board immediately upon his return.

17 B. On or about September 27, 2021, Respondent filed a Notice of Change of Address
18 form with the Board, indicating that he relocated to Beverly Hills, CA.

19 **THIRD CAUSE TO REVOKE PROBATION**

20 (Non-Practice While on Probation)

21 11. At all times after the effective date of Respondent's probation, Condition 12, Non-
22 Practice While on Probation, states, in pertinent part:

23 Respondent's period of non-practice while on probation shall not exceed two (2)
24 years.

25 ...

26 12. Respondent's probation is subject to revocation because he failed to comply with
27 Probation Condition 12, referenced above. The facts and circumstances regarding this violation
28 are as follows:

1 A. Respondent resided in Nevada on the effective date of Decision No. 800-2017-
2 030039, January 10, 2020. However, Respondent did not hold a medical license in the state of
3 Nevada. Respondent has been in non-practice status since the aforementioned effective date.

4 B. On or about April 16, 2021, Respondent was issued a non-practice letter indicating
5 that, as of July 10, 2021, his period of non-practice while on probation would exceed 18 calendar
6 months, and, as of January 10, 2022, his period of non-practice while on probation would exceed
7 two years.

8 C. On or about April 13, 2022, Respondent was issued a non-compliance letter
9 indicating that he exceeded two years of non-practice on January 10, 2022. The letter informed
10 Respondent that he needed to successfully complete the Federation of State Medical Board's
11 Special Purpose Examination or a Clinical Competence Assessment Program, and that this
12 violation of his probation could result in further disciplinary action against his medical license.

13 **FOURTH CAUSE TO REVOKE PROBATION**

14 (Violation of Probation)

15 13. At all times after the effective date of Respondent's probation, Condition 14,
16 Violation of Probation, states:

17 Failure to fully comply with any term or condition of probation is a violation of
18 probation. If Respondent violates probation in any respect, the Board, after giving
19 Respondent notice and the opportunity to be heard, may revoke probation and carry
20 out the disciplinary order that was stayed. If an Accusation, or Petition to Revoke
21 Probation, or an Interim Suspension Order is filed against Respondent during
22 probation, the Board shall have continuing jurisdiction until the matter is final, and
23 the period of probation shall be extended until the matter is final.

24 14. Respondent's probation is subject to revocation because he failed to comply with
25 Probation Condition 14, referenced above. The facts and circumstances regarding this violation
26 are as follows:

27 A. Paragraphs 7 through 12, inclusive, above, are incorporated herein by reference.



2. Revoking or suspending Physician's and Surgeon's Certificate No. A 137144, issued to Donald Dale Davidson, M.D.;
3. Revoking, suspending or denying approval of Donald Dale Davidson, M.D.'s authority to supervise physician assistants and advance practice nurses, pursuant to section 3527 of the Code;
4. Ordering Donald Dale Davidson, M.D. to pay the Medical Board of California, if placed on probation, the costs of probation monitoring; and
5. Taking such other and further action as deemed necessary and proper.



**STIPULATED SETTLEMENT AND
DISCIPLINARY ORDER**

18
19 **IT IS HEREBY STIPULATED AND AGREED** by and between the parties to the above-
20 entitled proceedings that the following matters are true:

21 **PARTIES**

22 1. Kimberly Kirchmeyer (Complainant) is the Executive Director of the Medical Board
23 of California (Board). She brought this action solely in her official capacity and is represented in
24 this matter by Xavier Becerra, Attorney General of the State of California, by Trina L. Saunders,
25 Deputy Attorney General.

26 2. Respondent Donald Dale Davidson, M.D. (Respondent) is represented in this
27 proceeding by attorney Yury Galperin of 801 Century Park East, 24th Floor, Los Angeles,
28 California 90067.

1 3. On June 18, 2015, the Board issued Physician's and Surgeon's Certificate No. A
2 137144 to Donald Dale Davidson, M.D. (Respondent). That license was in full force and effect at
3 all times relevant to the charges brought in Accusation No. 800-2017-030039, and will expire on
4 November 30, 2020, unless renewed.

5 **JURISDICTION**

6 4. A First Amended Accusation in case number 800-2017-030039 was filed before the
7 Board, and is currently pending against Respondent. The First Amended Accusation and all other
8 statutorily required documents were properly served on Respondent on August 9, 2019.
9 Respondent timely filed a Notice of Defense contesting the Accusation.

10 5. A copy of First Amended Accusation No. 800-2017-030039 is attached as Exhibit A
11 and is incorporated herein by reference.

12 **ADVISEMENT AND WAIVERS**

13 6. Respondent has carefully read, fully discussed with counsel, and understands the
14 charges and allegations in First Amended Accusation No. 800-2017-030039. Respondent has
15 also carefully read, fully discussed with counsel, and understands the effects of this Stipulated
16 Settlement and Disciplinary Order.

17 7. Respondent is fully aware of his legal rights in this matter, including the right to a
18 hearing on the charges and allegations in the Accusation; the right to confront and cross-examine
19 the witnesses against him; the right to present evidence and to testify on his own behalf; the right
20 to the issuance of subpoenas to compel the attendance of witnesses and the production of
21 documents; the right to reconsideration and court review of an adverse decision; and all other
22 rights accorded by the California Administrative Procedure Act and other applicable laws.

23 8. Respondent voluntarily, knowingly, and intelligently waives and gives up each and
24 every right set forth above.

25 **CULPABILITY**

26 9. Respondent admits the truth of each and every charge and allegation in First
27 Amended Accusation No. 800-2017-030039.

1 10. Respondent agrees that his Physician's and Surgeon's Certificate is subject to
2 discipline and he agrees to be bound by the Board's probationary terms as set forth in the
3 Disciplinary Order below.

4 CONTINGENCY

5 11. This stipulation shall be subject to approval by the Medical Board of California.
6 Respondent understands and agrees that counsel for Complainant and the staff of the Medical
7 Board of California may communicate directly with the Board regarding this stipulation and
8 settlement, without notice to or participation by Respondent or his counsel. By signing the
9 stipulation, Respondent understands and agrees that he may not withdraw his agreement or seek
10 to rescind the stipulation prior to the time the Board considers and acts upon it. If the Board fails
11 to adopt this stipulation as its Decision and Order, the Stipulated Settlement and Disciplinary
12 Order shall be of no force or effect, except for this paragraph, it shall be inadmissible in any legal
13 action between the parties, and the Board shall not be disqualified from further action by having
14 considered this matter.

15 12. The parties understand and agree that Portable Document Format (PDF) and facsimile
16 copies of this Stipulated Settlement and Disciplinary Order, including PDF and facsimile
17 signatures thereto, shall have the same force and effect as the originals.

18 13. In consideration of the foregoing admissions and stipulations, the parties agree that
19 the Board may, without further notice or formal proceeding, issue and enter the following
20 Disciplinary Order:

21 DISCIPLINARY ORDER

22 **IT IS HEREBY ORDERED THAT Physician's and Surgeon's Certificate No. A 137144**
23 **issued to Respondent Donald Dale Davidson, M.D. is revoked. However, the revocation is stayed**
24 **and Respondent is placed on probation for three (3) years on the following terms and conditions.**

25 1. EDUCATION COURSE. Within 60 calendar days of the effective date of this
26 Decision, and on an annual basis thereafter, Respondent shall submit to the Board or its designee
27 for its prior approval educational program(s) or course(s) which shall not be less than 40 hours
28 per year, for each year of probation. The educational program(s) or course(s) shall be aimed at

1 correcting any areas of deficient practice or knowledge and shall be Category I certified. The
2 educational program(s) or course(s) shall be at Respondent's expense and shall be in addition to
3 the Continuing Medical Education (CME) requirements for renewal of licensure. Following the
4 completion of each course, the Board or its designee may administer an examination to test
5 Respondent's knowledge of the course. Respondent shall provide proof of attendance for 65
6 hours of CME of which 40 hours were in satisfaction of this condition.

7 2. PRESCRIBING PRACTICES COURSE. Within 60 calendar days of the effective
8 date of this Decision, Respondent shall enroll in a course in prescribing practices approved in
9 advance by the Board or its designee. Respondent shall provide the approved course provider
10 with any information and documents that the approved course provider may deem pertinent.
11 Respondent shall participate in and successfully complete the classroom component of the course
12 not later than six (6) months after Respondent's initial enrollment. Respondent shall successfully
13 complete any other component of the course within one (1) year of enrollment. The prescribing
14 practices course shall be at Respondent's expense and shall be in addition to the Continuing
15 Medical Education (CME) requirements for renewal of licensure.

16 A prescribing practices course taken after the acts that gave rise to the charges in the
17 Accusation, but prior to the effective date of the Decision may, in the sole discretion of the Board
18 or its designee, be accepted towards the fulfillment of this condition if the course would have
19 been approved by the Board or its designee had the course been taken after the effective date of
20 this Decision.

21 Respondent shall submit a certification of successful completion to the Board or its
22 designee not later than 15 calendar days after successfully completing the course, or not later than
23 15 calendar days after the effective date of the Decision, whichever is later.

24 3. MEDICAL RECORD KEEPING COURSE. Within 60 calendar days of the effective
25 date of this Decision, Respondent shall enroll in a course in medical record keeping approved in
26 advance by the Board or its designee. Respondent shall provide the approved course provider
27 with any information and documents that the approved course provider may deem pertinent.
28 Respondent shall participate in and successfully complete the classroom component of the course

1 not later than six (6) months after Respondent's initial enrollment. Respondent shall successfully
2 complete any other component of the course within one (1) year of enrollment. The medical
3 record keeping course shall be at Respondent's expense and shall be in addition to the Continuing
4 Medical Education (CME) requirements for renewal of licensure.

5 A medical record keeping course taken after the acts that gave rise to the charges in the
6 Accusation, but prior to the effective date of the Decision may, in the sole discretion of the Board
7 or its designee, be accepted towards the fulfillment of this condition if the course would have
8 been approved by the Board or its designee had the course been taken after the effective date of
9 this Decision.

10 Respondent shall submit a certification of successful completion to the Board or its
11 designee not later than 15 calendar days after successfully completing the course, or not later than
12 15 calendar days after the effective date of the Decision, whichever is later.

13 4. MONITORING - PRACTICE. Within 30 calendar days of the effective date of this
14 Decision, Respondent shall submit to the Board or its designee for prior approval as a practice
15 monitor(s), the name and qualifications of one or more licensed physicians and surgeons whose
16 licenses are valid and in good standing, and who are preferably American Board of Medical
17 Specialties (ABMS) certified. A monitor shall have no prior or current business or personal
18 relationship with Respondent, or other relationship that could reasonably be expected to
19 compromise the ability of the monitor to render fair and unbiased reports to the Board, including
20 but not limited to any form of bartering, shall be in Respondent's field of practice, and must agree
21 to serve as Respondent's monitor. Respondent shall pay all monitoring costs.

22 The Board or its designee shall provide the approved monitor with copies of the Decision(s)
23 and Accusation(s), and a proposed monitoring plan. Within 15 calendar days of receipt of the
24 Decision(s), Accusation(s), and proposed monitoring plan, the monitor shall submit a signed
25 statement that the monitor has read the Decision(s) and Accusation(s), fully understands the role
26 of a monitor, and agrees or disagrees with the proposed monitoring plan. If the monitor disagrees
27 with the proposed monitoring plan, the monitor shall submit a revised monitoring plan with the
28 signed statement for approval by the Board or its designee.

1 Within 60 calendar days of the effective date of this Decision, and continuing throughout
2 probation, Respondent's practice shall be monitored by the approved monitor. Respondent shall
3 make all records available for immediate inspection and copying on the premises by the monitor
4 at all times during business hours and shall retain the records for the entire term of probation.

5 If Respondent fails to obtain approval of a monitor within 60 calendar days of the effective
6 date of this Decision, Respondent shall receive a notification from the Board or its designee to
7 cease the practice of medicine within three (3) calendar days after being so notified. Respondent
8 shall cease the practice of medicine until a monitor is approved to provide monitoring
9 responsibility.

10 The monitor(s) shall submit a quarterly written report to the Board or its designee which
11 includes an evaluation of Respondent's performance, indicating whether Respondent's practices
12 are within the standards of practice of medicine, and whether Respondent is practicing medicine
13 safely, billing appropriately or both. It shall be the sole responsibility of Respondent to ensure
14 that the monitor submits the quarterly written reports to the Board or its designee within 10
15 calendar days after the end of the preceding quarter.

16 If the monitor resigns or is no longer available, Respondent shall, within 5 calendar days of
17 such resignation or unavailability, submit to the Board or its designee, for prior approval, the
18 name and qualifications of a replacement monitor who will be assuming that responsibility within
19 15 calendar days. If Respondent fails to obtain approval of a replacement monitor within 60
20 calendar days of the resignation or unavailability of the monitor, Respondent shall receive a
21 notification from the Board or its designee to cease the practice of medicine within three (3)
22 calendar days after being so notified. Respondent shall cease the practice of medicine until a
23 replacement monitor is approved and assumes monitoring responsibility.

24 In lieu of a monitor, Respondent may participate in a professional enhancement program
25 approved in advance by the Board or its designee that includes, at minimum, quarterly chart
26 review, semi-annual practice assessment, and semi-annual review of professional growth and
27 education. Respondent shall participate in the professional enhancement program at Respondent's
28 expense during the term of probation.

1 5. PROHIBITED PRACTICE. During probation, Respondent is prohibited from
2 writing and issuing medical marijuana recommendations for the first year of probation. After the
3 effective date of this Decision, all patients being treated by the Respondent shall be notified that
4 the Respondent is prohibited from writing and issuing medical marijuana recommendations for a
5 year. Any new patients must be provided this notification at the time of their initial appointment.

6 Respondent shall maintain a log of all patients to whom the required oral notification was
7 made. The log shall contain the: 1) patient's name, address and phone number; 2) patient's
8 medical record number, if available; 3) the full name of the person making the notification; 4) the
9 date the notification was made; and 5) a description of the notification given. Respondent shall
10 keep this log in a separate file or ledger, in chronological order, shall make the log available for
11 immediate inspection and copying on the premises at all times during business hours by the Board
12 or its designee, and shall retain the log for the entire term of probation.

13 6. NOTIFICATION. Within seven (7) days of the effective date of this Decision, the
14 Respondent shall provide a true copy of this Decision and Accusation to the Chief of Staff or the
15 Chief Executive Officer at every hospital where privileges or membership are extended to
16 Respondent, at any other facility where Respondent engages in the practice of medicine,
17 including all physician and locum tenens registries or other similar agencies, and to the Chief
18 Executive Officer at every insurance carrier which extends malpractice insurance coverage to
19 Respondent. Respondent shall submit proof of compliance to the Board or its designee within 15
20 calendar days.

21 This condition shall apply to any change(s) in hospitals, other facilities or insurance carrier.

22 7. SUPERVISION OF PHYSICIAN ASSISTANTS AND ADVANCED PRACTICE
23 NURSES. During probation, Respondent is prohibited from supervising physician assistants and
24 advanced practice nurses.

25 8. OBEY ALL LAWS. Respondent shall obey all federal, state and local laws, all rules
26 governing the practice of medicine in California and remain in full compliance with any court
27 ordered criminal probation, payments, and other orders.

28 9. QUARTERLY DECLARATIONS. Respondent shall submit quarterly declarations

1 under penalty of perjury on forms provided by the Board, stating whether there has been
2 compliance with all the conditions of probation.

3 Respondent shall submit quarterly declarations not later than 10 calendar days after the end
4 of the preceding quarter.

5 10. GENERAL PROBATION REQUIREMENTS.

6 Compliance with Probation Unit

7 Respondent shall comply with the Board's probation unit.

8 Address Changes

9 Respondent shall, at all times, keep the Board informed of Respondent's business and
10 residence addresses, email address (if available), and telephone number. Changes of such
11 addresses shall be immediately communicated in writing to the Board or its designee. Under no
12 circumstances shall a post office box serve as an address of record, except as allowed by Business
13 and Professions Code section 2021(b).

14 Place of Practice

15 Respondent shall not engage in the practice of medicine in Respondent's or patient's place
16 of residence, unless the patient resides in a skilled nursing facility or other similar licensed
17 facility.

18 License Renewal

19 Respondent shall maintain a current and renewed California physician's and surgeon's
20 license.

21 Travel or Residence Outside California

22 Respondent shall immediately inform the Board or its designee, in writing, of travel to any
23 areas outside the jurisdiction of California which lasts, or is contemplated to last, more than thirty
24 (30) calendar days.

25 In the event Respondent should leave the State of California to reside or to practice
26 , Respondent shall notify the Board or its designee in writing 30 calendar days prior to the dates of
27 departure and return.

28 11. INTERVIEW WITH THE BOARD OR ITS DESIGNEE. Respondent shall be

1 available in person upon request for interviews either at Respondent's place of business or at the
2 probation unit office, with or without prior notice throughout the term of probation.

3 12. NON-PRACTICE WHILE ON PROBATION. Respondent shall notify the Board or
4 its designee in writing within 15 calendar days of any periods of non-practice lasting more than
5 30 calendar days and within 15 calendar days of Respondent's return to practice. Non-practice is
6 defined as any period of time Respondent is not practicing medicine as defined in Business and
7 Professions Code sections 2051 and 2052 for at least 40 hours in a calendar month in direct
8 patient care, clinical activity or teaching, or other activity as approved by the Board. If
9 Respondent resides in California and is considered to be in non-practice, Respondent shall
10 comply with all terms and conditions of probation. All time spent in an intensive training
11 program which has been approved by the Board or its designee shall not be considered non-
12 practice and does not relieve Respondent from complying with all the terms and conditions of
13 probation. Practicing medicine in another state of the United States or Federal jurisdiction while
14 on probation with the medical licensing authority of that state or jurisdiction shall not be
15 considered non-practice. A Board-ordered suspension of practice shall not be considered as a
16 period of non-practice.

17 In the event Respondent's period of non-practice while on probation exceeds 18 calendar
18 months, Respondent shall successfully complete the Federation of State Medical Boards' Special
19 Purpose Examination, or, at the Board's discretion, a clinical competence assessment program
20 that meets the criteria of Condition 18 of the current version of the Board's "Manual of Model
21 Disciplinary Orders and Disciplinary Guidelines" prior to resuming the practice of medicine.

22 Respondent's period of non-practice while on probation shall not exceed two (2) years.

23 Periods of non-practice will not apply to the reduction of the probationary term.

24 Periods of non-practice for a Respondent residing outside of California will relieve
25 Respondent of the responsibility to comply with the probationary terms and conditions with the
26 exception of this condition and the following terms and conditions of probation: Obey All Laws;
27 General Probation Requirements; Quarterly Declarations; Abstain from the Use of Alcohol and/or
28 Controlled Substances; and Biological Fluid Testing.

1 13. COMPLETION OF PROBATION. Respondent shall comply with all financial
2 obligations (e.g., restitution, probation costs) not later than 120 calendar days prior to the
3 completion of probation. Upon successful completion of probation, Respondent's certificate shall
4 be fully restored.

5 14. VIOLATION OF PROBATION. Failure to fully comply with any term or condition
6 of probation is a violation of probation. If Respondent violates probation in any respect, the
7 Board, after giving Respondent notice and the opportunity to be heard, may revoke probation and
8 carry out the disciplinary order that was stayed. If an Accusation, or Petition to Revoke Probation,
9 or an Interim Suspension Order is filed against Respondent during probation, the Board shall have
10 continuing jurisdiction until the matter is final, and the period of probation shall be extended until
11 the matter is final.

12 15. LICENSE SURRENDER. Following the effective date of this Decision, if
13 Respondent ceases practicing due to retirement or health reasons or is otherwise unable to satisfy
14 the terms and conditions of probation, Respondent may request to surrender his or her license.
15 The Board reserves the right to evaluate Respondent's request and to exercise its discretion in
16 determining whether or not to grant the request, or to take any other action deemed appropriate
17 and reasonable under the circumstances. Upon formal acceptance of the surrender, Respondent
18 shall within 15 calendar days deliver Respondent's wallet and wall certificate to the Board or its
19 designee and Respondent shall no longer practice medicine. Respondent will no longer be subject
20 to the terms and conditions of probation. If Respondent re-applies for a medical license, the
21 application shall be treated as a petition for reinstatement of a revoked certificate.

22 16. PROBATION MONITORING COSTS. Respondent shall pay the costs associated
23 with probation monitoring each and every year of probation, as designated by the Board, which
24 may be adjusted on an annual basis. Such costs shall be payable to the Medical Board of
25 California and delivered to the Board or its designee no later than January 31 of each calendar
26 year.





21 PARTIES

22 1. Kimberly Kirchmeyer (Complainant) brings this Accusation solely in her official
23 capacity as the Executive Director of the Medical Board of California (Board).

24 2. On June 18, 2015, the Board issued Physician's and Surgeon's Certificate Number A
25 137144 to Donald Dale Davidson, M.D. (Respondent). That license was in full force and effect at
26 all times relevant to the charges brought herein and will expire on November 30, 2020, unless
27 renewed.

JURISDICTION

1
2 3. This Accusation is brought before the Board under the authority of the following
3 laws. All section references are to the Business and Professions Code unless otherwise indicated.

4 4. Section 2227 of the Code states:

5 “(a) A licensee whose matter has been heard by an administrative law judge of the Medical
6 Quality Hearing Panel as designated in Section 11371 of the Government Code, or whose default
7 has been entered, and who is found guilty, or who has entered into a stipulation for disciplinary
8 action with the board, may, in accordance with the provisions of this chapter:

9 “(1) Have his or her license revoked upon order of the board.

10 “(2) Have his or her right to practice suspended for a period not to exceed one year upon
11 order of the board.

12 “(3) Be placed on probation and be required to pay the costs of probation monitoring upon
13 order of the board.

14 “(4) Be publicly reprimanded by the board. The public reprimand may include a
15 requirement that the licensee complete relevant educational courses approved by the board.

16 “(5) Have any other action taken in relation to discipline as part of an order of probation, as
17 the board or an administrative law judge may deem proper.

18 “(b) Any matter heard pursuant to subdivision (a), except for warning letters, medical
19 review or advisory conferences, professional competency examinations, continuing education
20 activities, and cost reimbursement associated therewith that are agreed to with the board and
21 successfully completed by the licensee, or other matters made confidential or privileged by
22 existing law, is deemed public, and shall be made available to the public by the board pursuant to
23 Section 803.1.”

24 5. Section 2234 of the Code, states:

25 “The board shall take action against any licensee who is charged with unprofessional
26 conduct. In addition to other provisions of this article, unprofessional conduct includes, but is not
27 limited to, the following:
28

1 “(a) Violating or attempting to violate, directly or indirectly, assisting in or abetting the
2 violation of, or conspiring to violate any provision of this chapter.

3 “(b) Gross negligence.

4 “(c) Repeated negligent acts. To be repeated, there must be two or more negligent acts or
5 omissions. An initial negligent act or omission followed by a separate and distinct departure from
6 the applicable standard of care shall constitute repeated negligent acts.

7 “(1) An initial negligent diagnosis followed by an act or omission medically appropriate for
8 that negligent diagnosis of the patient shall constitute a single negligent act.

9 “(2) When the standard of care requires a change in the diagnosis, act, or omission that
10 constitutes the negligent act described in paragraph (1), including, but not limited to, a
11 reevaluation of the diagnosis or a change in treatment, and the licensee’s conduct departs from the
12 applicable standard of care, each departure constitutes a separate and distinct breach of the
13 standard of care.

14 “(d) Incompetence.

15 “(e) The commission of any act involving dishonesty or corruption which is substantially
16 related to the qualifications, functions, or duties of a physician and surgeon.

17 “(f) Any action or conduct which would have warranted the denial of a certificate.

18 “(g) The practice of medicine from this state into another state or country without meeting
19 the legal requirements of that state or country for the practice of medicine. Section 2314 shall not
20 apply to this subdivision. This subdivision shall become operative upon the implementation of the
21 proposed registration program described in Section 2052.5.

22 “(h) The repeated failure by a certificate holder, in the absence of good cause, to attend and
23 participate in an interview by the board. This subdivision shall only apply to a certificate holder
24 who is the subject of an investigation by the board.”

25 6. . Section 2525.3 of the Code states: “Recommending medical cannabis to a patient for
26 a medical purpose without an appropriate prior examination and a medical indication constitutes
27 unprofessional conduct.”

28

1 palpation, auscultation, percussion, neurological tests and a mental health examination were not
2 performed or documented.

3 13. Patient B received a medical marijuana recommendation from Respondent on
4 November 13, 2017.

5 14. Respondent did not attempt to corroborate patient B's self-reported medical history.
6 He did not request copies of patient B's prior medical records, nor did he attempt to speak with
7 the patient's treating physician or any prior treating physician of the patient.

8 15. The medical record does not contain support for the decision to recommend medical
9 cannabis to treat insomnia and stress.

10 Patient C

11 16. On September 8, 2017, Patient C, an undercover special investigator, posed as a new
12 patient. He had a medical marijuana consultation with Respondent using the mobile app
13 EazeMD, which he downloaded to his work iPhone. Patient C filled out a questionnaire in which
14 he indicated that he had stress that impacted his daily activities by sometimes impacting his sleep.
15 He indicated, "No," to the question asking if he had any alcohol or drug problems. He also
16 indicated that he used cannabis in the past and it helped his condition.

17 17. He then selected to be connected to a physician. Respondent appeared on the
18 connection. He asked Patient C if he had any questions about marijuana. The undercover special
19 investigator said that he did not. Respondent asked Patient C if he had any alcohol or substance
20 abuse problems. The agent reported that he did not. That completed the evaluation.

21 18. Respondent documented that Patient C had insomnia. No patient vital signs were
22 recorded. There is no record of temperature, heart rate, or blood pressure. Essential elements of a
23 good faith examination, including inspection, palpation, auscultation, percussion, neurological
24 tests and a mental health examination were not performed or documented.

25 19. Patient C received a medical marijuana recommendation from Respondent on
26 September 8, 2017.

27 ///

1 20. Respondent did not attempt to corroborate patient C's self-reported medical history.
2 He did not request copies of patient C's prior medical records, nor did he attempt to speak with
3 the patient's treating physician or any prior treating physician of the patient.

4 **FIRST CAUSE FOR DISCIPLINE**

5 (Repeated Negligent Acts)

6 21. Respondent is subject to disciplinary action under section 2234, subdivision (c), of
7 the Code in that Respondent issued marijuana recommendations to three patients without
8 appropriate physical examinations and failed to corroborate the medical history of each of the
9 three patients. The circumstances are as follows:

10 22. Complainant refers to and, by this reference, incorporates paragraphs 8 through 20
11 above, as though fully set forth herein.

12 23. In each of the patient cases, Respondent failed to obtain and perform a good faith
13 examination of the patient prior to providing the patient with a medical marijuana
14 recommendation.

15 24. In each of the patient cases, Respondent did not attempt to obtain the prior medical
16 records of the patient and did not attempt to speak to the treating physician of the patients. He
17 also failed to attempt to obtain the prior medical records of each of the patients, and did not
18 speak to the treating physicians of the patients to corroborate their medical history.

19 **SECOND CAUSE FOR DISCIPLINE**

20 (Failure to Maintain Adequate Records)

21 25. Respondent's license is subject to disciplinary action under Section 2266 of the Code,
22 in that Respondent failed to maintain adequate and accurate medical records. Respondent failed
23 to keep adequate records that support his decision to recommend medical marijuana to each of the
24 patients. The circumstances are as follows:

25 26. Complainant refers to and, by this reference, incorporates paragraphs 8 through 20
26 above, as though fully set forth herein.

1 THIRD CAUSE FOR DISCIPLINE

2 (Unprofessional Conduct)

3 27. By reason of the facts set forth in paragraphs 8 through 20 above, Respondent's
4 license is subject to disciplinary action under Section 2234, subdivision (a) of the Code, in that
5 Respondent failed to perform a good faith examination of each patient prior to providing the
6 patient with a medical marijuana recommendation.

7 PRAYER

8 WHEREFORE, Complainant requests that a hearing be held on the matters herein alleged,
9 and that following the hearing, the Medical Board of California issue a decision:


10 1. Revoking or suspending Physician's and Surgeon's Certificate Number A 137144,
11 issued to Donald Dale Davidson, M.D.;

12 2. Revoking, suspending or denying approval of his authority to supervise physician
13 assistants and advanced practice nurses;

14 3. If placed on probation, ordering him to pay the Board the costs of probation
15 monitoring; and

16 4. Taking such other and further action as deemed necessary and proper.
