**AGREEMENT FOR
SURRENDER OF REGISTRATION**

TO ALL PARTIES:

IT IS HEREBY STIPULATED AND AGREED by and between the parties to the above-entitled proceedings, that the following matters are true:

1. Complainant, Reji Varghese, is the Executive Director of the Medical Board of California, Department of Consumer Affairs ("Board").
2. Donna Jean Wren ("Applicant") has carefully read and fully understands the effect of this Agreement.
3. Applicant understands that by signing this Agreement she is enabling the Board to issue this order accepting the surrender of registration without further process. Applicant understands and agrees that Board staff and counsel for Complainant may communicate directly with the Board regarding this Agreement, without notice to or participation by Applicant. The Board will not be disqualified from further action in this matter by virtue of its consideration of this Agreement.
4. Applicant acknowledges there is current disciplinary action against her registration, that on September 14, 2022, a Decision was rendered wherein, Applicant was issued a probationary polysomnographic training registration for 3 years with various standard terms and conditions.

1 5. The current disciplinary action provides in pertinent part, "Following the
2 effective date of this Decision, if Applicant ceases practicing due to retirement, or
3 health reasons, or is otherwise unable to satisfy the terms and conditions of
4 probation, Applicant may request to surrender Applicant's registration." (Condition
5 #11).

6 6. Upon acceptance of the Agreement by the Board, Applicant
7 understands she will no longer be permitted to practice as a polysomnographic
8 trainee in California.

9 7. Applicant fully understands and agrees that if Applicant ever files an
10 application for recertification or reinstatement in the State of California, the Board
11 shall treat it as a Petition for Reinstatement of a revoked registration in effect at
12 the time the Petition is filed. In addition, any Medical Board Investigation
13 Report(s), including all referenced documents and other exhibits, upon which the
14 Board is predicated, and any such Investigation Report(s), attachments, and other
15 exhibits, that may be generated subsequent to the filing of this Agreement for
16 Surrender of Registration, shall be admissible as direct evidence, and any time-
17 based defenses, such as laches or any applicable statute of limitations, shall be
18 waived when the Board determines whether to grant or deny the Petition.
