**AGREEMENT FOR
SURRENDER OF LICENSE**

15 **Physician's and Surgeon's**

18 **TO ALL PARTIES:**

19 **IT IS HEREBY STIPULATED AND AGREED** by and between the parties to the above-
20 entitled proceedings, that the following matters are true:

21 1. Complainant, Reji Varghese is the Executive Director of the Medical Board of
22 California, Department of Consumer Affairs ("Board").

23 2. Roy Johnson King, Jr., M.D. ("Respondent") has carefully read and fully
24 understands the effect of this Agreement for Surrender of License.

25 3. Respondent understands that by signing this Agreement for Surrender of License
26 (Agreement) Respondent is enabling the Board to issue this order accepting the surrender of
27 Respondent's Physician's and Surgeon's Certificate, No. G 43227, which expired on April 30,
28 2024, and has not been renewed, without further process. Respondent understands and agrees
that Board staff and counsel for Complainant may communicate directly with the Board regarding
this Agreement, without notice to or participation by Respondent. The Board will not be

1 disqualified from further action in this matter by virtue of its consideration of this Agreement.

2 4. Respondent acknowledges there is a current investigation matter – Case No. 800-
3 2022-088437 – against his Physician's and Surgeon's Certificate, No. G 43227.

4 5. Upon acceptance of the Agreement by the Board, Respondent understands he will
5 no longer be permitted to practice as a physician and surgeon in California, and also agrees to
6 surrender his wallet certificate, wall license and any D.E.A. Certificate(s) for an address in
7 California.

8 6. Respondent fully understands and agrees that if Respondent ever files an
9 application for re-licensure or reinstatement in the State of California, the Board shall treat it as a
10 Petition for Reinstatement of a revoked license in effect at the time the Petition is filed. In
11 addition, any Medical Board Investigation Report(s), including all referenced documents and
12 other exhibits, upon which the Board is predicated, and any such Investigation Report(s),
13 attachments, and other exhibits, that may be generated subsequent to the filing of this Agreement
14 for Surrender of License, including but not limited to investigation 800-2022-088437, shall be
15 admissible as direct evidence, and any time-based defenses, such as laches or any applicable
16 statute of limitations, shall be waived when the Board determines whether to grant or deny the
17 Petition.

18 7. Respondent shall pay the agency its costs of investigation and enforcement in the
19 amount of \$6,985.00 prior to issuance of a new or reinstated license.




