**NOTICE OF AUTOMATIC
REVOCATION OF LICENSE**

20 TO ERIC SCOTT SILLS, M.D.:

21 YOU ARE HEREBY NOTIFIED that the Medical Board of California, Department of
22 Consumer Affairs (Board), has automatically revoked Physician's and Surgeon's Certificate
23 No. G 88985 by operation of law after having received and reviewed a certified copy of the
24 record of conviction described below:

25 1. On or about December 19, 2023, in the proceeding entitled *The People of the State of*
26 *California v. Eric Scott Sills.*, Superior Court of California, County of Orange, Case No.
27 19HF0572, Eric Scott Sills, M.D. (Respondent) was found guilty, by jury verdict, of one felony
28 violation of Penal Code section 187, subdivision (a) (*Second Degree Murder*), a felony.

1 2. On or about March 15, 2024, Respondent was sentenced to fifteen (15) years to life in
2 prison, with the possibility of parole. Respondent was remanded to the custody of the Sheriff and
3 the Sheriff was ordered to deliver Respondent to the custody of the Department of Corrections
4 forthwith.

5 3. On December 19, 2025, the California Court of Appeal affirmed the conviction.

11 **FELONY CONVICTION: AUTOMATIC REVOCATION**

12 5. Section 2232.5 of the Business and Professions Code states, in pertinent part:

13 ...

14 (b) (3) Serious felonies as defined in Section 1192.7 of the Penal Code.

15 ...

16 (c) (1) Following the conviction of a felony as described in subdivision (b), the board or
17 its designee shall automatically revoke a license at such time as the time for appeal has
18 elapsed with no appeal having been taken, or the judgment of conviction having been
19 affirmed on appeal, or the judgment of conviction having otherwise become final.

19 ...

20 (d) (1) The licensee may request a hearing within 30 days of the automatic suspension
21 order described in subdivision (a) and the automatic revocation order described in
22 subdivision (c). The proceeding shall be conducted in accordance with the Administrative
23 Procedure Act (Chapter 5 (commencing with Section 11500) of Part 1 of Division 3 of
24 Title 2 of the Government Code) except as provided in paragraph (2).

25 (2) The Legislature finds and declares that the conviction of any felony identified in
26 subdivision (b) is substantially related to the practice of medicine. An administrative law
27 judge shall not permit or give any weight to expert testimony regarding whether the
28 conviction is substantially related to the practice of medicine. The only purpose of an
administrative hearing shall be to determine whether the discipline imposed shall be a
suspension, revocation, or other action under the circumstances of the case.
