On February 19, 2026, an Order was issued in *The People of the State of California vs. Hong An Jan*, Orange County Superior Court, Case No. 26HF0187 by Karen L. Robinson, Judge Presiding. Under the Order, as a condition of bail, HONG-AN JAN, M.D. (Physician's and Surgeon's Certificate Number A 31743) is prohibited from the practice of medicine in the State of California during pendency of Orange County Superior Court Case No. 26HF0187, including completion of any criminal probation, effective February 19, 2026. 28 Applicant appeared through counsel, Rob Bonta, Attorney General of the State of California, by


1 Jason J. Ahn, Deputy Attorney General. Defendant Hong An Jan (Defendant) appeared with his
