**STIPULATED SETTLEMENT AND
DISCIPLINARY ORDER**

21
22 IT IS HEREBY STIPULATED AND AGREED by and between the parties to the above-
23 entitled proceedings that the following matters are true:

24 **PARTIES**

25 1. Christine J. Lally (Complainant) is the Interim Executive Director of the Medical
26 Board of California (Board). She brought this action solely in her official capacity and is
27 represented in this matter by Xavier Becerra, Attorney General of the State of California, by
28 Megan R. O'Carroll, Deputy Attorney General.

1 8. Respondent voluntarily, knowingly, and intelligently waives and gives up each and
2 every right set forth above.

3 CULPABILITY

4 9. Respondent understands and agrees that the charges and allegations in First Amended
5 Accusation No. 800-2016-026090, if proven at a hearing, constitute cause for imposing discipline
6 upon his Physician's and Surgeon's Certificate.

7 10. Respondent agrees that, at a hearing, Complainant could establish a prima facie case
8 for the charges in the First Amended Accusation, and that Respondent hereby gives up his right to
9 contest those charges.

10 11. Respondent does not contest that, at an administrative hearing, complainant could
11 establish a prima facie case with respect to the charges and allegations in First Amended
12 Accusation No. 800-2016-026090, a true and correct copy of which is attached hereto as Exhibit
13 A, and that he has thereby subjected his Physician's and Surgeon's Certificate, No. A 112472 to
14 disciplinary action.

15 12. Respondent agrees that his Physician's and Surgeon's Certificate is subject to
16 discipline and he agrees to be bound by the Board's probationary terms as set forth in the
17 Disciplinary Order below.

18 CONTINGENCY

19 13. This stipulation shall be subject to approval by the Medical Board of California.
20 Respondent understands and agrees that counsel for Complainant and the staff of the Medical
21 Board of California may communicate directly with the Board regarding this stipulation and
22 settlement, without notice to or participation by Respondent or his counsel. By signing the
23 stipulation, Respondent understands and agrees that he may not withdraw his agreement or seek
24 to rescind the stipulation prior to the time the Board considers and acts upon it. If the Board fails
25 to adopt this stipulation as its Decision and Order, the Stipulated Settlement and Disciplinary
26 Order shall be of no force or effect, except for this paragraph, it shall be inadmissible in any legal
27 action between the parties, and the Board shall not be disqualified from further action by having
28 considered this matter.

1 14. Respondent agrees that if he ever petitions for early termination or modification of
 2 probation, or if an accusation and/or petition to revoke probation is filed against him before the
 3 Board, all of the charges and allegations contained in First Amended Accusation No. 800-2016-
 4 026090 shall be deemed true, correct and fully admitted by respondent for purposes of any such
 5 proceeding or any other licensing proceeding involving Respondent in the State of California.

6 15. The parties understand and agree that Portable Document Format (PDF) and facsimile
 7 copies of this Stipulated Settlement and Disciplinary Order, including PDF and facsimile
 8 signatures thereto, shall have the same force and effect as the originals.

9 16. In consideration of the foregoing admissions and stipulations, the parties agree that
 10 the Board may, without further notice or opportunity to be heard by the Respondent, issue and
 11 enter the following Disciplinary Order:

12 **DISCIPLINARY ORDER**

13 IT IS HEREBY ORDERED that Physician’s and Surgeon’s Certificate No. A 112472
 14 issued to Respondent Peter Lap Wong, M.D. is revoked. However, the revocation is stayed and
 15 Respondent is placed on probation for thirty-five (35) months on the following terms and
 16 conditions:

17 1. **EDUCATION COURSE.** Within 60 calendar days of the effective date of this
 18 Decision, and on an annual basis thereafter, Respondent shall submit to the Board or its designee
 19 for its prior approval educational program(s) or course(s) which shall not be less than 25 hours
 20 per year, for each year of probation. The educational program(s) or course(s) shall be aimed at
 21 correcting any areas of deficient practice or knowledge and shall be Category I certified. The
 22 educational program(s) or course(s) shall be at Respondent’s expense and shall be in addition to
 23 the Continuing Medical Education (CME) requirements for renewal of licensure. Following the
 24 completion of each course, the Board or its designee may administer an examination to test
 25 Respondent’s knowledge of the course. Respondent shall provide proof of attendance to the
 26 Board or its designee of satisfaction of this requirement.

27 2. **MEDICAL RECORD KEEPING COURSE.** Within 60 calendar days of the effective
 28 date of this Decision, Respondent shall enroll in a course in medical record keeping approved in

1 advance by the Board or its designee. Respondent shall provide the approved course provider
2 with any information and documents that the approved course provider may deem pertinent.
3 Respondent shall participate in and successfully complete the classroom component of the course
4 not later than six (6) months after Respondent's initial enrollment. Respondent shall successfully
5 complete any other component of the course within one (1) year of enrollment. The medical
6 record keeping course shall be at Respondent's expense and shall be in addition to the Continuing
7 Medical Education (CME) requirements for renewal of licensure.

8 A medical record keeping course taken after the acts that gave rise to the charges in the
9 Accusation, but prior to the effective date of the Decision may, in the sole discretion of the Board
10 or its designee, be accepted towards the fulfillment of this condition if the course would have
11 been approved by the Board or its designee had the course been taken after the effective date of
12 this Decision.

13 Respondent shall submit a certification of successful completion to the Board or its
14 designee not later than 15 calendar days after successfully completing the course, or not later than
15 15 calendar days after the effective date of the Decision, whichever is later.

16 3. PROFESSIONALISM PROGRAM (ETHICS COURSE). Within 60 calendar days of
17 the effective date of this Decision, Respondent shall enroll in a professionalism program, that
18 meets the requirements of Title 16, California Code of Regulations (CCR) section 1358.1.
19 Respondent shall participate in and successfully complete that program. Respondent shall
20 provide any information and documents that the program may deem pertinent. Respondent shall
21 successfully complete the classroom component of the program not later than six (6) months after
22 Respondent's initial enrollment, and the longitudinal component of the program not later than the
23 time specified by the program, but no later than one (1) year after attending the classroom
24 component. The professionalism program shall be at Respondent's expense and shall be in
25 addition to the Continuing Medical Education (CME) requirements for renewal of licensure.

26 A professionalism program taken after the acts that gave rise to the charges in the
27 Accusation, but prior to the effective date of the Decision may, in the sole discretion of the Board
28 or its designee, be accepted towards the fulfillment of this condition if the program would have

1 been approved by the Board or its designee had the program been taken after the effective date of
2 this Decision.

3 Respondent shall submit a certification of successful completion to the Board or its
4 designee not later than 15 calendar days after successfully completing the program or not later
5 than 15 calendar days after the effective date of the Decision, whichever is later.

6 4. MONITORING - PRACTICE. Within 30 calendar days of the effective date of this
7 Decision, Respondent shall submit to the Board or its designee for prior approval as a practice
8 monitor(s), the name and qualifications of one or more licensed physicians and surgeons whose
9 licenses are valid and in good standing, and who are preferably American Board of Medical
10 Specialties (ABMS) certified. A monitor shall have no prior or current business or personal
11 relationship with Respondent, or other relationship that could reasonably be expected to
12 compromise the ability of the monitor to render fair and unbiased reports to the Board, including
13 but not limited to any form of bartering, shall be in Respondent's field of practice, and must agree
14 to serve as Respondent's monitor. Respondent shall pay all monitoring costs.

15 The Board or its designee shall provide the approved monitor with copies of the Decision(s)
16 and First Amended Accusation(s), and a proposed monitoring plan. Within 15 calendar days of
17 receipt of the Decision(s), First Amended Accusation(s), and proposed monitoring plan, the
18 monitor shall submit a signed statement that the monitor has read the Decision(s) and First
19 Amended Accusation(s), fully understands the role of a monitor, and agrees or disagrees with the
20 proposed monitoring plan. If the monitor disagrees with the proposed monitoring plan, the
21 monitor shall submit a revised monitoring plan with the signed statement for approval by the
22 Board or its designee.

23 Within 60 calendar days of the effective date of this Decision, and continuing throughout
24 probation, Respondent's practice shall be monitored by the approved monitor. Respondent shall
25 make all records available for immediate inspection and copying on the premises by the monitor
26 at all times during business hours and shall retain the records for the entire term of probation.

27 If Respondent fails to obtain approval of a monitor within 60 calendar days of the effective
28 date of this Decision, Respondent shall receive a notification from the Board or its designee to

1 cease the practice of medicine within three (3) calendar days after being so notified. Respondent
2 shall cease the practice of medicine until a monitor is approved to provide monitoring
3 responsibility.

4 The monitor(s) shall submit a quarterly written report to the Board or its designee which
5 includes an evaluation of Respondent's performance, indicating whether Respondent's practices
6 are within the standards of practice of medicine, and whether Respondent is practicing medicine
7 safely. It shall be the sole responsibility of Respondent to ensure that the monitor submits the
8 quarterly written reports to the Board or its designee within 10 calendar days after the end of the
9 preceding quarter.

10 If the monitor resigns or is no longer available, Respondent shall, within 5 calendar days of
11 such resignation or unavailability, submit to the Board or its designee, for prior approval, the
12 name and qualifications of a replacement monitor who will be assuming that responsibility within
13 15 calendar days. If Respondent fails to obtain approval of a replacement monitor within 60
14 calendar days of the resignation or unavailability of the monitor, Respondent shall receive a
15 notification from the Board or its designee to cease the practice of medicine within three (3)
16 calendar days after being so notified. Respondent shall cease the practice of medicine until a
17 replacement monitor is approved and assumes monitoring responsibility.

18 In lieu of a monitor, Respondent may participate in a professional enhancement program
19 approved in advance by the Board or its designee that includes, at minimum, quarterly chart
20 review, semi-annual practice assessment, and semi-annual review of professional growth and
21 education. Respondent shall participate in the professional enhancement program at Respondent's
22 expense during the term of probation.

23 5. NOTIFICATION. Within seven (7) days of the effective date of this Decision, the
24 Respondent shall provide a true copy of this Decision and First Amended Accusation to the Chief
25 of Staff or the Chief Executive Officer at every hospital where privileges or membership are
26 extended to Respondent, at any other facility where Respondent engages in the practice of
27 medicine, including all physician and locum tenens registries or other similar agencies, and to the
28 Chief Executive Officer at every insurance carrier which extends malpractice insurance coverage

1 to Respondent. Respondent shall submit proof of compliance to the Board or its designee within
2 15 calendar days.

3 This condition shall apply to any change(s) in hospitals, other facilities or insurance carrier.

4 6. SUPERVISION OF PHYSICIAN ASSISTANTS AND ADVANCED PRACTICE
5 NURSES. During probation, Respondent is prohibited from supervising physician assistants and
6 advanced practice nurses.

7 7. OBEY ALL LAWS. Respondent shall obey all federal, state and local laws, all rules
8 governing the practice of medicine in California and remain in full compliance with any court
9 ordered criminal probation, payments, and other orders.

10 8. QUARTERLY DECLARATIONS. Respondent shall submit quarterly declarations
11 under penalty of perjury on forms provided by the Board, stating whether there has been
12 compliance with all the conditions of probation.

13 Respondent shall submit quarterly declarations not later than 10 calendar days after the end
14 of the preceding quarter.

15 9. GENERAL PROBATION REQUIREMENTS.

16 Compliance with Probation Unit

17 Respondent shall comply with the Board's probation unit.

18 Address Changes

19 Respondent shall, at all times, keep the Board informed of Respondent's business and
20 residence addresses, email address (if available), and telephone number. Changes of such
21 addresses shall be immediately communicated in writing to the Board or its designee. Under no
22 circumstances shall a post office box serve as an address of record, except as allowed by Business
23 and Professions Code section 2021, subdivision (b).

24 Place of Practice

25 Respondent shall not engage in the practice of medicine in Respondent's or patient's place
26 of residence, unless the patient resides in a skilled nursing facility or other similar licensed
27 facility.

28 License Renewal

1 Respondent shall maintain a current and renewed California physician's and surgeon's
2 license.

3 Travel or Residence Outside California

4 Respondent shall immediately inform the Board or its designee, in writing, of travel to any
5 areas outside the jurisdiction of California which lasts, or is contemplated to last, more than thirty
6 (30) calendar days.

7 In the event Respondent should leave the State of California to reside or to practice
8 ,Respondent shall notify the Board or its designee in writing 30 calendar days prior to the dates of
9 departure and return.

10 10. INTERVIEW WITH THE BOARD OR ITS DESIGNEE. Respondent shall be
11 available in person upon request for interviews either at Respondent's place of business or at the
12 probation unit office, with or without prior notice throughout the term of probation.

13 11. NON-PRACTICE WHILE ON PROBATION. Respondent shall notify the Board or
14 its designee in writing within 15 calendar days of any periods of non-practice lasting more than
15 30 calendar days and within 15 calendar days of Respondent's return to practice. Non-practice is
16 defined as any period of time Respondent is not practicing medicine as defined in Business and
17 Professions Code sections 2051 and 2052 for at least 40 hours in a calendar month in direct
18 patient care, clinical activity or teaching, or other activity as approved by the Board. If
19 Respondent resides in California and is considered to be in non-practice, Respondent shall
20 comply with all terms and conditions of probation. All time spent in an intensive training
21 program which has been approved by the Board or its designee shall not be considered non-
22 practice and does not relieve Respondent from complying with all the terms and conditions of
23 probation. Practicing medicine in another state of the United States or Federal jurisdiction while
24 on probation with the medical licensing authority of that state or jurisdiction shall not be
25 considered non-practice. A Board-ordered suspension of practice shall not be considered as a
26 period of non-practice.

27 In the event Respondent's period of non-practice while on probation exceeds 18 calendar
28 months, Respondent shall successfully complete the Federation of State Medical Boards's Special

1 Purpose Examination, or, at the Board's discretion, a clinical competence assessment program
2 that meets the criteria of Condition 18 of the current version of the Board's "Manual of Model
3 Disciplinary Orders and Disciplinary Guidelines" prior to resuming the practice of medicine.

4 Respondent's period of non-practice while on probation shall not exceed two (2) years.

5 Periods of non-practice will not apply to the reduction of the probationary term.

6 Periods of non-practice for a Respondent residing outside of California will relieve
7 Respondent of the responsibility to comply with the probationary terms and conditions with the
8 exception of this condition and the following terms and conditions of probation: Obey All Laws;
9 General Probation Requirements; Quarterly Declarations; Abstain from the Use of Alcohol and/or
10 Controlled Substances; and Biological Fluid Testing..

11 12. COMPLETION OF PROBATION. Respondent shall comply with all financial
12 obligations (e.g., restitution, probation costs) not later than 120 calendar days prior to the
13 completion of probation. Upon successful completion of probation, Respondent's certificate shall
14 be fully restored.

15 13. VIOLATION OF PROBATION. Failure to fully comply with any term or condition
16 of probation is a violation of probation. If Respondent violates probation in any respect, the
17 Board, after giving Respondent notice and the opportunity to be heard, may revoke probation and
18 carry out the disciplinary order that was stayed. If an Accusation, or Petition to Revoke Probation,
19 or an Interim Suspension Order is filed against Respondent during probation, the Board shall have
20 continuing jurisdiction until the matter is final, and the period of probation shall be extended until
21 the matter is final.

22 14. LICENSE SURRENDER. Following the effective date of this Decision, if
23 Respondent ceases practicing due to retirement or health reasons or is otherwise unable to satisfy
24 the terms and conditions of probation, Respondent may request to surrender his or her license.
25 The Board reserves the right to evaluate Respondent's request and to exercise its discretion in
26 determining whether or not to grant the request, or to take any other action deemed appropriate
27 and reasonable under the circumstances. Upon formal acceptance of the surrender, Respondent
28 shall within 15 calendar days deliver Respondent's wallet and wall certificate to the Board or its

1 designee and Respondent shall no longer practice medicine. Respondent will no longer be subject
2 to the terms and conditions of probation. If Respondent re-applies for a medical license, the
3 application shall be treated as a petition for reinstatement of a revoked certificate.


4 15. PROBATION MONITORING COSTS. Respondent shall pay the costs associated
5 with probation monitoring each and every year of probation, as designated by the Board, which
6 may be adjusted on an annual basis. Such costs shall be payable to the Medical Board of
7 California and delivered to the Board or its designee no later than January 31 of each calendar
8 year.

9 16. FUTURE ADMISSIONS CLAUSE. If Respondent should ever apply or reapply for
10 a new license or certification, or petition for reinstatement of a license, by any other health care
11 licensing action agency in the State of California, all of the charges and allegations contained in
12 First Amended Accusation No. 800-2016-026090 shall be deemed to be true, correct, and
13 admitted by Respondent for the purpose of any Statement of Issues or any other proceeding
14 seeking to deny or restrict license.

15 ACCEPTANCE

16 I have carefully read the above Stipulated Settlement and Disciplinary Order and have fully
17 discussed it with my attorney, Gregory Abrams. I understand the stipulation and the effect it will
18 have on my Physician's and Surgeon's Certificate. I enter into this Stipulated Settlement and
19 Disciplinary Order voluntarily, knowingly, and intelligently, and agree to be bound by the
20 Decision and Order of the Medical Board of California.



FIRST AMENDED ACCUSATION

20 Complainant alleges:

21 **PARTIES**

- 22 1. Christine J. Lally (Complainant) brings this First Amended Accusation solely in her
23 official capacity as the Interim Executive Director of the Medical Board of California,
24 Department of Consumer Affairs (Board).
- 25 2. On or about May 19, 2010, the Board issued Physician's and Surgeon's Certificate
26 Number A 112472 to Peter Lap Wong, M.D. (Respondent). The Physician's and Surgeon's
27 Certificate was in full force and effect at all times relevant to the charges brought herein and will
28 expire on November 30, 2021, unless renewed.

1 **JURISDICTION**

2 3. Section 2227 of the Code provides that a licensee who is found guilty under the
3 Medical Practice Act may have his or her license revoked, suspended for a period not to exceed
4 one year, placed on probation and required to pay the costs of probation monitoring, or such other
5 action taken in relation to discipline as the Board deems proper.

6 4. Section 2234 of the Code, states:

7 The board shall take action against any licensee who is charged with
8 unprofessional conduct. In addition to other provisions of this article, unprofessional
9 conduct includes, but is not limited to, the following:

10 (a) Violating or attempting to violate, directly or indirectly, assisting in or
11 abetting the violation of, or conspiring to violate any provision of this chapter.

12 (b) Gross negligence.

13 (c) Repeated negligent acts. To be repeated, there must be two or more
14 negligent acts or omissions. An initial negligent act or omission followed by a
15 separate and distinct departure from the applicable standard of care shall constitute
16 repeated negligent acts.

17 (1) An initial negligent diagnosis followed by an act or omission medically
18 appropriate for that negligent diagnosis of the patient shall constitute a single
19 negligent act.

20 (2) When the standard of care requires a change in the diagnosis, act, or
21 omission that constitutes the negligent act described in paragraph (1), including, but
22 not limited to, a reevaluation of the diagnosis or a change in treatment, and the
23 licensee's conduct departs from the applicable standard of care, each departure
24 constitutes a separate and distinct breach of the standard of care.

25 (d) Incompetence.

26 (e) The commission of any act involving dishonesty or corruption which is
27 substantially related to the qualifications, functions, or duties of a physician and
28 surgeon.

(f) Any action or conduct which would have warranted the denial of a
certificate.

(g) The practice of medicine from this state into another state or country
without meeting the legal requirements of that state or country for the practice of
medicine. Section 2314 shall not apply to this subdivision. This subdivision shall
become operative upon the implementation of the proposed registration program
described in Section 2052.5.

(h) The repeated failure by a certificate holder, in the absence of good cause, to
attend and participate in an interview by the board. This subdivision shall only apply
to a certificate holder who is the subject of an investigation by the board.

1 5. Unprofessional conduct under section 2234 of the Code is conduct which breaches
2 the rules or ethical code of the medical profession, or conduct which is unbecoming a member in
3 good standing of the medical profession, and which demonstrates an unfitness to practice
4 medicine. (*Shea v. Bd. of Medical Examiners* (1978) 81 Cal.App.3d 564, 575.)

5 **FACTS**

6 6. Respondent is Board-certified in General Surgery. Respondent was employed as a
7 general surgeon at Mercy Medical Center in Merced between 2010 and 2016.

8 **Patient 1**

9 7. Patient 1 was a 53-year old man with a history of alcohol abuse when he was
10 transferred, on a ventilator, to Mercy Hospital on or about November 25, 2012.¹ He had
11 presented to Madera Community Hospital before the transfer, with altered mental status,
12 vomiting, abdominal pain, diarrhea for five days, abnormal heart rate (150), and possible alcohol
13 withdrawal. He had been intubated at Madera following respiratory failure, likely due to necrotic
14 bowel and septic shock. He was given Levaquin and Flagyl. A computerized tomography scan,
15 (CT), performed at Madera showed pneumatosis coli, and likely necrotic bowel in the ascending
16 right colon, with gas extending to the right kidney, along with retroperitoneal fluid and air
17 tracking towards the diaphragm.

18 8. Patient 1's physical examination showed a mass present in his flank. He had a white
19 blood cell count of 25, bilirubin of 1.7, and a lactate of 5. Patient 1 was hepatitis C negative. On
20 or about November 25, 2012, Respondent wrote an initial consultation note, timed at 10:23 a.m.,
21 documenting that Patient 1 was experiencing septic shock and coagulopathy, and required
22 vasopressors. Respondent noted Patient 1's International Normalized Ratio was 2 and that he
23 needed to have this corrected before surgery could take place.

24 9. Patient 1 consented to an exploratory laparotomy, which Respondent performed later
25 in the day, on or about November 25, 2012. Respondent found that Patient 1 likely had a
26 gangrenous or ischemic intestine. Respondent's dictated operative note stated that Patient 1 had a
27 perforated right colon and extension to the colic gutter, and that one liter of blood was evacuated.

28 ¹ The patients in this Accusation are referred to by numbers to protect their privacy.

1 To treat this, Respondent performed a right hemicolectomy and end ileostomy and a left Jackson
2 Pratt drain. The operative note further suggests, "Invasion of peritoneum and subcutaneous space
3 of right abdominal wall." It also noted that the liver was non-cirrhotic.

4 10. The pathology report stated that the right colon had serositis and mesenteric abscess.
5 There was inflammation, but the pathologist reported that the colon appeared viable. The
6 pathologist did not note gangrene or perforation, and the resected specimen had viable margins.
7 There was a mesenteric abscess, periappendicitis, and adherent clot.

8 11. Postoperatively, by November 27, 2012, the nurses noted a high bilious dark green
9 output from the Jackson Pratt drain. At this point, Respondent considered possible necrosis
10 extending into the duodenum. Patient 1's family consented to a repeat exploration surgery to
11 wash out the abdomen and exclude a missed injury.

12 12. On or about November 27, 2012, Respondent performed a second exploratory surgery
13 and mobilization of the duodenum and found no evidence of a missed perforation. The intra-
14 abdominal fluid was drained and the abdomen was washed out as planned. Patient 1 did well for
15 the next ten days, but on or about December 6, 2012, Respondent became concerned that stool
16 may be draining into the Jackson Pratt drain, so he ordered a gastrograffin study.

17 13. The gastrograffin small bowel series study was determined to be normal. On or about
18 December 8, 2012, a gastrograffin enema was ordered for further study. That was also found to
19 be normal, and the new surgery plan was to do a hepatobiliary iminodiacetic acid (HIDA) scan.
20 An abdominal ultrasound done on or about December 9, 2012, was relatively normal, with
21 edematous gallbladder, and possible fluid or blood adjacent to the kidney. The HIDA scan, done
22 on or about December 10, 2012, showed a small biliary leak from the gallbladder fossa in the
23 right upper quadrant, possibly from the liver or the gallbladder. Respondent made a note on or
24 about December 11, 2012, at 11:00 a.m. that there was a small bile leak, and recommended and
25 consented Patient 1 for a third exploratory surgery.

26 14. On or about December 12, 2012, Respondent took Patient 1 to surgery for the third
27 time. He had difficulty entering the abdomen, and he was unable to visualize the gallbladder due
28

1 to adhesions. He aborted the procedure, replaced a drain, and started Patient 1 on octreotide. On
2 or about December 17, 2012 Respondent stopped the octreotide.

3 15. On or about December 25, 2012, a CT of Patient 1 showed the drain was dislodged.
4 It also showed Patient 1 had a 10 x 3 x 6 paraspinal abscess, and a right pararenal abscess. The
5 gallbladder was normal. There was also a parastomal abscess. On or about December 26, 2012,
6 the plan was to proceed with an interventional radiology drainage of the two abscesses. Two
7 drains were placed, one in the parastomal abscess and the other in the right 8 centimeter
8 retroperitoneal abscess. On or about December 30, 2012, microbiology analysis of the culture
9 revealed Enterobacter. On or about December 31, 2012, a CT scan from interventional radiology
10 showed that the parastomal abscess was resolved, and the paraspinal abscess was now smaller.
11 Patient 1 improved, and was discharged. His main diagnoses on discharge were right psoas
12 abscess and right pararenal abscess

13 **Patient 2**

14 16. Patient 2 was a 55-year old man when he was admitted to Mercy Medical Center on
15 or about January 3, 2013, with acute cholecystitis, dehydration, and hypokalemia. Patient 2 had a
16 history of hypertension and was taking Diovan. He had no fever, but he reported severe
17 abdominal pain. His heart rate was 120, and his other vital signs were normal. A CT scan
18 showed a thickened gallbladder wall and fluid around the gallbladder suggesting cholecystitis.
19 His platelet count was abnormally low, at 28. Upon recheck it was even lower, at 14, and later
20 went back up to 30. His bilirubin was 1.4. A hematology consultation was ordered for him.

21 17. An ultrasound performed on January 3, 2012 confirmed gallstones, possibly at the
22 neck of the gallbladder, a possible stone in the common bile duct, and a possible thrombus in the
23 left portal vein. Respondent evaluated Patient 2 on or about January 4, 2013, and recommended a
24 laparoscopic cholecystectomy be performed when Patient 2's platelet level rose to at least 100.
25 On or about January 5, 2013, Respondent saw Patient 2 in the evening and wrote a note indicating
26 that Patient 2's platelets were at 23, and he may consider an Interventional Radiology
27 cholecystostomy tube as a possible alternative if Patient 2's platelet count remains unsafe for
28 surgery.

1 18. Patient 2 saw both a gastroenterologist and a hematologist. The hematologist ordered
2 intravenous immunoglobulin and steroids for Patient 2 and planned for a possible bone marrow
3 biopsy. On or about January 6, 2013, Patient 2's platelet count rose to 118. His white blood cell
4 count was down from 18 to 13, as he was being treated with antibiotics. On or about January 6,
5 2013, Respondent prepared a surgical plan and obtained informed consent from Patient 2.

6 19. During the surgery, Respondent found Patient 2's gallbladder to be very inflamed.
7 An intraoperative cholangiogram showed what Respondent believed to be a filling defect² in the
8 proximal common bile duct. Respondent noted that when taking the gallbladder off the
9 gallbladder wall, he took off a small portion of the right hepatic branch, which caused bleeding
10 from the right hepatic vein, which required him to place two clips to stop the bleeding. Because of
11 the presumed bile duct stone, Respondent requested a gastroenterology consultation for extraction
12 by Endoscopic Retrograde Cholangio-Pancreatograph (ERCP).

13 20. The operative cholangiogram was read as normal distally by radiology. The
14 radiologist did not visualize the proximal biliary tree. The pathologist report found no acute
15 cholecystitis and no evidence of a common bile duct structure. On or about January 7, 2013, at
16 postoperative day 1, Patient 2's bilirubin was 5.8. The surgery progress note confirms that there
17 was no visualization of hepatic ducts, and the plan was to do an ERCP.

18 21. An ERCP was performed on or about January 7, 2013, and showed non-visualization
19 of the common hepatic or intrahepatic ductal structures. There was a possible extravasation of
20 contrast into the periductal tissues at the level of the cystic duct. There were no intraluminal
21 filling defects, and the duct appeared to taper to occlusion just inferior to the surgical clips. The
22 plan was now to perform a Magnetic Resonance Cholangio-Pancreatograph (MRCP).

23 22. On or about January 8, 2013, Patient 2's abnormal laboratory results included
24 bilirubin at 9.1, alkaline phosphatase of 489, abnormal liver enzymes with AST at 104, and an
25 ALT of 66. Respondent's progress note questioned a possible "hepatic duct blockage." The
26 ERCP findings were reviewed with a note of "blockage in proximal common bile duct." Patient 2

27 ² A filling defect is a term of art in radiological terminology, intended to indicate an
28 interruption in the surface being imaged. Filling defects in the common bile duct may indicate
the presence of a stone or a cyst.

1 was then consented for "open common bile duct exploration," due to the blockage of the common
2 bile duct, which was also noted on the cholangiogram.

3 23. On or about January 8, 2013, Respondent attempted to repair the common bile duct
4 and perform a primary reanastomosis, but a t-tube could not be inserted. The Roux-en-Y
5 reconstruction was not done. On or about January 9, 2013, Patient 2's blood cultures showed the
6 presence of Klebsiella. Patient 2 had a high output of bile in the Jackson Pratt drain, and a repeat
7 MRCP was considered and ordered. The repeat MRCP was not performed, however, because
8 Patient 2's family intervened and requested a transfer to another hospital for further treatment.
9 On or about January 10, 2013, while awaiting transfer to a higher level of care, Patient 2's drain
10 showed 450 cc output. Possible Mirizzi's syndrome was considered. By January 11, 2013,
11 Patient 2's laboratory results had improved to bilirubin of 1.8, alkaline phosphatase of 270, with
12 normal liver enzymes and mild hyponatremia. Patient 2 was receiving platelets and partial
13 parenteral nutrition.

14 24. On or about January 13, 2013, Patient 2 was transferred to a higher level of care. His
15 documented discharge diagnoses included common bile duct injury, Mirizzi's syndrome, and
16 thrombocytopenia. There was no radiologic evidence to support the diagnosis of Mirizzi's
17 syndrome, which is a very rare condition.

18 25. Respondent failed to stop the laparoscopic procedure on or about January 6, 2013,
19 and to convert to an open procedure when the intraoperative cholangiogram did not show the
20 biliary tree to verify flow both distally into the duodenum and proximally into the liver. He
21 misinterpreted the abnormal findings of the biliary anatomy and misinterpreted the abnormal
22 cholangiogram as a bile duct stone, rather than an occluded common bile duct just below the
23 hepatic bifurcation. The conversion would have decreased the risk of damage to the common bile
24 duct, made it easier to diagnose, and could have facilitated a simple t-tube repair during the initial
25 surgery. Patient 2 had a common bile duct injury high at the level of the right and left hepatic
26 ducts. This type of injury may require a hepaticojejunostomy and biliary stenting to reconstruct
27 the biliary tree.

28

1 **FIRST CAUSE FOR DISCIPLINE**

2 **(Gross Negligence)**

3 26. Respondent is subject to disciplinary action under section under section 2234,
4 subdivision (b), in that he committed gross negligence in his care and treatment. The
5 circumstances are as follows:

6 27. Paragraphs 6, and 16 through 25 above are incorporated by reference as if fully set
7 forth herein.

8 28. Respondent was grossly negligent in his care and treatment of Patient 2 for his acts
9 and omissions including, but not limited to, the following:

10 (a) Failing to convert the laparoscopic procedure on Patient 2 on or about January 6, 2013,
11 into an open procedure when the cholangiogram did not demonstrate flow both distally into the
12 duodenum and proximally into the liver; and

13 (b) Failing to refer Patient 2 to a higher level of care or to a surgeon with expertise in
14 performing more extensive repair procedures like a hepaticojejunostomy once the injury to the
15 common bile duct was apparent.

16 **SECOND CAUSE FOR DISCIPLINE**

17 **(Repeated Negligent Acts)**

18 29. Respondent is subject to disciplinary action under section 2234, subdivision (c), in
19 that he was repeatedly negligent. The circumstances are as follows:

20 30. Paragraphs 6 through 28 above are incorporated by reference as if fully set forth
21 herein.

22 31. Respondent was repeatedly negligent in his care and treatment of Patients 1 and 2, for
23 his acts and omissions including, but not limited to, the following:

24 (a) Deciding on or about December 11, 2012, to reenter Patient 1's abdomen, despite the
25 recent, previous laparotomy and in the absence of uncontrolled intra-abdominal sepsis;

26 (b) Failing to convert the laparoscopic procedure on Patient 2 on or about January 6, 2013,
27 into an open procedure when the cholangiogram did not demonstrate flow both distally into the
28 duodenum and proximally into the liver; and

1 (c) Failing to refer Patient 2 to a higher level of care or to a surgeon with expertise in
2 performing more extensive repair procedures like a hepaticojejunostomy once the injury to the
3 common bile duct was apparent.

4 **THIRD CAUSE FOR DISCIPLINE**

5 **(Unprofessional Conduct)**


6 32. Respondent is subject to disciplinary action under section 2234 of the code in that he
7 has engaged in conduct which breaches the rules or ethical code of the medical profession, or
8 conduct which is unbecoming to a member in good standing of the medical profession, and which
9 demonstrates an unfitness to practice medicine, as more particularly alleged in paragraphs 6
10 through 31, above, which are hereby incorporated by reference and re-alleged as if fully set forth
11 herein.

12 **PRAYER**

13 WHEREFORE, Complainant requests that a hearing be held on the matters herein alleged,
14 and that following the hearing, the Medical Board of California issue a decision:

- 15 1. Revoking or suspending Physician's and Surgeon's Certificate Number A 112472,
16 issued to Peter Lap Wong, M.D.;
- 17 2. Revoking, suspending or denying approval of Peter Lap Wong, M.D.'s authority to
18 supervise physician assistants and advanced practice nurses;
- 19 3. Ordering Peter Lap Wong, M.D., if placed on probation, to pay the Board the costs of
20 probation monitoring; and
- 21 4. Taking such other and further action as deemed necessary and proper.
