STIPULATED SETTLEMENT AND
DISCIPLINARY ORDER

19
20 In the interest of a prompt and speedy settlement of this matter, consistent with the public
21 interest and the responsibility of the Medical Board of California of the Department of Consumer
22 Affairs, the parties hereby agree to the following Stipulated Settlement and Disciplinary Order
23 which will be submitted to the Board for approval and adoption as the final disposition of the
24 First Amended Accusation.

25 **PARTIES**

26 1. William Prasifka (Complainant) is the Executive Director of the Medical Board of
27 California (Board). He brought this action solely in his official capacity and is represented in this
28

1 matter by Rob Bonta, Attorney General of the State of California, by Lynette D. Hecker, Deputy
2 Attorney General.

3 2. Eric Colburn Disbrow, M.D. (Respondent) is represented in this proceeding by
4 attorney Marvin Firestone, MD, JD, whose address is: 1700 South El Camino Real, Ste. 408, San
5 Mateo, CA 94402.

6 3. On or about August 9, 1971, the Board issued Physician's and Surgeon's Certificate
7 No. G 21038 to Respondent. The Physician's and Surgeon's Certificate was in full force and
8 effect at all times relevant to the charges brought in First Amended Accusation No. 800-2018-
9 045589, and will expire on January 31, 2023, unless renewed.

10 JURISDICTION

11 4. First Amended Accusation No. 800-2018-045589 was filed before the Board, and is
12 currently pending against Respondent. The original Accusation and all other statutorily required
13 documents were properly served on Respondent on June 16, 2021. Respondent timely filed his
14 Notice of Defense contesting the Accusation. The First Amended Accusation and all other
15 statutorily required documents were properly served on Respondent on April 5, 2022. This
16 stipulation shall serve as Respondent's Notice of Defense pursuant to Government Code section
17 11506, subdivision (a)(4).

18 5. A copy of the First Amended Accusation No. 800-2018-045589 is attached as
19 "Exhibit A" and incorporated herein by reference.

20 ADVISEMENT AND WAIVERS

21 6. Respondent has carefully read, fully discussed with counsel, and understands the
22 charges and allegations in First Amended Accusation No. 800-2018-045589. Respondent has
23 also carefully read, fully discussed with his counsel, and understands the effects of this Stipulated
24 Settlement and Disciplinary Order.

25 7. Respondent is fully aware of his legal rights in this matter, including the right to a
26 hearing on the charges and allegations in the First Amended Accusation; the right to confront and
27 cross-examine the witnesses against him; the right to present evidence and to testify on his own
28 behalf; the right to the issuance of subpoenas to compel the attendance of witnesses and the

1 production of documents; the right to reconsideration and court review of an adverse decision;
2 and all other rights accorded by the California Administrative Procedure Act and other applicable
3 laws.

4 8. Respondent voluntarily, knowingly, and intelligently waives and gives up each and
5 every right set forth above.

6 CULPABILITY

7 9. Respondent understands and agrees that the charges and allegations in First Amended
8 Accusation No. 800-2018-045589, if proven at a hearing, constitute cause for imposing discipline
9 upon his Physician's and Surgeon's Certificate.

10 10. Respondent does not contest that, at an administrative hearing, Complainant could
11 establish a *prima facie* case or factual basis with respect to the charges and allegations in First
12 Amended Accusation, that he has thereby subjected his Physician's and Surgeon's Certificate,
13 No. G 21038 to disciplinary action, and Respondent hereby gives up his right to contest those
14 charges. Respondent agrees that if in any future case he ever petitions for early termination or
15 modification of probation, or if the Board ever petitions for revocation of probation, all of the
16 charges and allegations contained in First Amended Accusation No. 800-2018-045589 shall be
17 deemed true, correct, and fully admitted by Respondent for purposes of that proceeding or any
18 other licensing proceeding involving Respondent in the State of California.

19 11. Respondent agrees that his Physician's and Surgeon's Certificate is subject to
20 discipline and he agrees to be bound by the Board's imposition of discipline as set forth in the
21 Disciplinary Order below.

22 CONTINGENCY

23 12. This stipulation shall be subject to approval by the Medical Board of California.
24 Respondent understands and agrees that counsel for Complainant and the staff of the Medical
25 Board of California may communicate directly with the Board regarding this stipulation and
26 settlement, without notice to or participation by Respondent or his counsel. By signing the
27 stipulation, Respondent understands and agrees that he may not withdraw his agreement or seek
28 to rescind the stipulation prior to the time the Board considers and acts upon it. If the Board fails

1 to adopt this stipulation as its Decision and Order, the Stipulated Settlement and Disciplinary
2 Order shall be of no force or effect, except for this paragraph, it shall be inadmissible in any legal
3 action between the parties, and the Board shall not be disqualified from further action by having
4 considered this matter.

5 13. The parties understand and agree that Portable Document Format (PDF) and facsimile
6 copies of this Stipulated Settlement and Disciplinary Order, including PDF and facsimile
7 signatures thereto, shall have the same force and effect as the originals.

8 14. In consideration of the foregoing admissions and stipulations, the parties agree that
9 the Board may, without further notice or opportunity to be heard by the Respondent, issue and
10 enter the following Disciplinary Order:

11 **DISCIPLINARY ORDER**

12 **A. PUBLIC REPRIMAND**

13 IT IS HEREBY ORDERED that Respondent Eric Colburn Disbrow, M.D., Physician's and
14 Surgeon's Certificate No. G 21038, shall be and is hereby Publicly Reprimanded pursuant to
15 California Business and Professions Code section 2227, subdivision (a)(4). This Public
16 Reprimand is issued in connection with Respondent's recordkeeping pertaining to five patients, as
17 set forth in First Amended Accusation No. 800-2018-045589.

18 1. **INVESTIGATION/ENFORCEMENT COST RECOVERY:** Respondent is hereby
19 relieved from reimbursing the Board its costs of investigation and enforcement under Code
20 section 125.3.

21 2. **FUTURE ADMISSIONS CLAUSE:** If Respondent should ever apply or reapply for
22 a new license or certification, or petition for reinstatement of a license, by any other health care
23 licensing action agency in the State of California, all of the charges and allegations contained in
24 Accusation No. 800-2018-045589 shall be deemed to be true, correct, and admitted by
25 Respondent for the purpose of any Statement of Issues or any other proceeding seeking to deny or
26 restrict license.





19 **PARTIES**

20 1. William Prasifka (Complainant) brings this First Amended Accusation solely in his
21 official capacity as the Executive Director of the Medical Board of California, Department of
22 Consumer Affairs (Board).

23 2. On or about August 9, 1971, the Medical Board issued Physician's and Surgeon's
24 Certificate Number G 21038 to Eric Colburn Disbrow, M.D. (Respondent). The Physician's and
25 Surgeon's Certificate was in full force and effect at all times relevant to the charges brought
26 herein and will expire on January 31, 2023, unless renewed.

27 ///

28 ///

1 JURISDICTION

2 3. This First Amended Accusation is brought before the Board, under the authority of
3 the following laws. All section references are to the Business and Professions Code (Code)
4 unless otherwise indicated.

5 4. Section 2227 of the Code states:

6 (a) A licensee whose matter has been heard by an administrative law judge of
7 the Medical Quality Hearing Panel as designated in Section 11371 of the Government
8 Code, or whose default has been entered, and who is found guilty, or who has entered
9 into a stipulation for disciplinary action with the board, may, in accordance with the
10 provisions of this chapter:

11 (1) Have his or her license revoked upon order of the board.

12 (2) Have his or her right to practice suspended for a period not to exceed one
13 year upon order of the board.

14 (3) Be placed on probation and be required to pay the costs of probation
15 monitoring upon order of the board.

16 (4) Be publicly reprimanded by the board. The public reprimand may include a
17 requirement that the licensee complete relevant educational courses approved by the
18 board.

19 (5) Have any other action taken in relation to discipline as part of an order of
20 probation, as the board or an administrative law judge may deem proper.

21 (b) Any matter heard pursuant to subdivision (a), except for warning letters,
22 medical review or advisory conferences, professional competency examinations,
23 continuing education activities, and cost reimbursement associated therewith that are
24 agreed to with the board and successfully completed by the licensee, or other matters
25 made confidential or privileged by existing law, is deemed public, and shall be made
26 available to the public by the board pursuant to Section 803.1.

27 5. Section 2234 of the Code, states:

28 The board shall take action against any licensee who is charged with
unprofessional conduct. In addition to other provisions of this article, unprofessional
conduct includes, but is not limited to, the following:

(a) Violating or attempting to violate, directly or indirectly, assisting in or
abetting the violation of, or conspiring to violate any provision of this chapter.

(b) Gross negligence.

(c) Repeated negligent acts. To be repeated, there must be two or more
negligent acts or omissions. An initial negligent act or omission followed by a
separate and distinct departure from the applicable standard of care shall constitute
repeated negligent acts.

///

1 (1) An initial negligent diagnosis followed by an act or omission medically
2 appropriate for that negligent diagnosis of the patient shall constitute a single
negligent act.

3 (2) When the standard of care requires a change in the diagnosis, act, or
4 omission that constitutes the negligent act described in paragraph (1), including, but
5 not limited to, a reevaluation of the diagnosis or a change in treatment, and the
licensee's conduct departs from the applicable standard of care, each departure
constitutes a separate and distinct breach of the standard of care.

6 (d) Incompetence.

7 (e) The commission of any act involving dishonesty or corruption that is
8 substantially related to the qualifications, functions, or duties of a physician and
surgeon.

9 (f) Any action or conduct that would have warranted the denial of a certificate.

10 (g) The failure by a certificate holder, in the absence of good cause, to attend
11 and participate in an interview by the board. This subdivision shall only apply to a
certificate holder who is the subject of an investigation by the board.

12 6. Section 2266 of the Code states: The failure of a physician and surgeon to maintain
13 adequate and accurate records relating to the provision of services to their patients constitutes
14 unprofessional conduct.

15 COST RECOVERY

16 7. Section 125.3 of the Code provides, in pertinent part, that the Board may request the
17 administrative law judge to direct a licensee found to have committed a violation or violations of
18 the licensing act to pay a sum not to exceed the reasonable costs of the investigation and
19 enforcement of the case¹, with failure of the licensee to comply subjecting the license to not being
20 renewed or reinstated. If a case settles, recovery of investigation and enforcement costs may be
21 included in a stipulated settlement.

22 DEFINITIONS

23 8. Acetaminophen and hydrocodone bitartrate (Vicodin® and Norco®) is a combination
24 of two medicines used to treat moderate to severe pain. Hydrocodone is an opioid pain
25 medication, commonly referred to as a narcotic. Acetaminophen is a less potent pain reliever that

1 increases the effects of hydrocodone. Hydrocodone has a high potential for abuse. Hydrocodone
2 is a Schedule II controlled substance and narcotic as defined by section 11055, subdivision (b)(1)
3 of the Health and Safety Code, and a Schedule II controlled substance as defined by Section
4 1308.12 (b)(1) of Title 21 of the code of Federal Regulations and a dangerous drug as defined in
5 Business and Professions Code section 4022.

6 9. Alprazolam (Xanax®) is in the class of benzodiazepine medications. It affects
7 chemicals in the brain that may be unbalanced in people with anxiety. Xanax is used to treat
8 anxiety disorders, panic disorders, and anxiety caused by depression. Xanax has the potential for
9 abuse. Xanax is a Schedule IV controlled substance pursuant to Health and Safety Code section
10 11057, subdivision (d), and a dangerous drug pursuant to Business and Professions Code section
11 4022.

12 10. Arthralgia is pain in one or more of a person's joints. The pain may be described as
13 sharp, dull, stabbing, burning or throbbing, and may range in intensity from mild to severe. There
14 are many causes of arthralgia, including injury, infection, arthritis, and other ailments.

15 11. Cervicalgia is a common term used to describe neck pain -- often referred to as a
16 "crick in the neck." General neck pain can arise from various causes including poor posture,
17 muscle fatigue from overuse or even from poor sleeping positions.

18 12. Chronic obstructive pulmonary disease (COPD) is a chronic inflammatory lung
19 disease that causes obstructed airflow from the lungs. Symptoms include breathing difficulty,
20 cough, mucus (sputum) production and wheezing.

21 13. Fentanyl transdermal (Duragesic®) patches are a Schedule II controlled substance
22 pursuant to Health and Safety Code section 11055, subdivision (c), and a dangerous drug
23 pursuant to Business and Professions Code section 4022. Fentanyl transdermal system is a means
24 for conveyance of fentanyl to the patient via a patch that adheres to the skin, releasing the
25 substance via absorption, over time. When properly prescribed and indicated fentanyl
26 transdermal patches are indicated for the management of pain in opioid-tolerant patients, severe
27 enough to require daily, around-the-clock, long term opioid treatment and for which alternative
28 treatment options are inadequate. The FDA has issued several black box warnings about fentanyl

1 transdermal patches including, but not limited to, the risks of addiction, abuse and misuse; life
2 threatening respiratory depression; accidental exposure; neonatal opioid withdrawal syndrome;
3 and the risks associated with the concomitant use with benzodiazepines or other CNS depressants.

4 14. Klonopin® (clonazepam), a benzodiazepine, is a centrally acting hypnotic-sedative
5 that is a Schedule IV controlled substance pursuant to Health and Safety Code section 11057,
6 subdivision (d), and a dangerous drug pursuant to Business and Professions Code section 4022.
7 When properly prescribed and indicated, it is used to treat seizure disorders and panic disorders.
8 Concomitant use of Klonopin® with opioids “may result in profound sedation, respiratory
9 depression, coma, and death.” The Drug Enforcement Administration (DEA) has identified
10 benzodiazepines, such as Klonopin®, as drug of abuse. (Drugs of Abuse, DEA Resource Guide
11 (2011 Edition), at p. 53.) Klonopin® has a half-life of 20-50 hours such that twice daily dosing is
12 usually sufficient to prevent a build-up of bioavailable medication. Caution is advised when
13 prescribed in combination with hydromorphone due to an increased risk of respiratory depression.

14 15. Methadone is an opioid medication that has a high potential for abuse. It is a
15 dangerous drug as defined in section 4022 and a Schedule II controlled substance and narcotic as
16 defined by section 11055 of the Health and Safety Code. Methadone is used as a pain reliever
17 and as part of drug addiction detoxification and maintenance programs. It may cause a prolonged
18 QT interval (a rare heart problem that may cause irregular heartbeat, fainting, or sudden death).

19 16. Myalgia describes muscle aches and pain, which can involve ligaments, tendons and
20 fascia, the soft tissues that connect muscles, bones and organs. Injuries, trauma, overuse, tension,
21 certain drugs and illnesses can all bring about myalgia.

22 17. Naprosyn is a prescription medicine used to treat the symptoms of pain or
23 inflammation caused by arthritis, ankylosing spondylitis, tendinitis, bursitis, gout or menstrual
24 cramps. Naprosyn may be used alone or with other medications. Naprosyn is a nonsteroidal anti-
25 inflammatory medication (NSAID) and is not a controlled substance.

26 18. Oxycodone is an opioid pain medication, commonly referred to as a narcotic.
27 Oxycodone has a high potential for abuse. Oxycodone is a Schedule II controlled substance and
28 narcotic as defined by section 11055, subdivision (b)(1) of the Health and Safety Code, and a

1 Schedule II controlled substance as defined by Section 1308.12 (b)(1) of Title 21 of the code of
2 Federal Regulations and a dangerous drug as defined in Business and Professions Code section
3 4022. Oxycodone should be used with caution and started in a reduced dosage (1/3 to 1/2 of the
4 usual dosage) in patients who are concurrently receiving other central nervous system depressants
5 including sedatives or hypnotics, general anesthetics, phenothiazines, other tranquilizers, and
6 alcohol. The Drug Enforcement Administration (“DEA”) has identified opioids, such as
7 oxycodone, as a drug of abuse. (Drugs of Abuse, DEA Resource Guide (2011 Edition), at p. 41.)
8 Respiratory depression is the chief hazard from all opioid agonist preparations.

9 19. Peripheral neuropathy refers to the conditions that result when nerves that carry
10 messages to and from the brain and spinal cord from and to the rest of the body are damaged or
11 diseased. The peripheral nerves make up an intricate network that connects the brain and spinal
12 cord to the muscles, skin, and internal organs.

13 20. Stenosis, which means narrowing, can cause pressure on the spinal cord or the nerves
14 that go from the spinal cord to muscles. Spinal stenosis can happen in any part of the spine but is
15 most common in the lower back. This part of your spine is called the lumbar area.

16 21. Trigger finger is a condition in which a finger gets stuck in a bent position. The
17 finger may bend or straighten with a snap — like a trigger being pulled and released. Trigger
18 finger is also known as stenosing tenosynovitis because it is caused by a narrowing of the
19 structures around the affected tendon.

20 FACTUAL ALLEGATIONS²

21 22. Respondent is Board-Certified in family practice and geriatric medicine. Respondent
22 works approximately three days a week at Atwater Medical Clinic and attends to nursing homes
23 the rest of the week. All five of the patients whose care and treatment is the subject of this case
24 came under Respondent’s care at Atwater Medical Clinic.

25 ///

1 **CIRCUMSTANCES RELATED TO PATIENT A³**

2 23. Patient A is a 57-year-old male with a history of anxiety, COPD, depression, fatigue,
3 high cholesterol, lumbar disc disease, obstructive sleep apnea, osteoarthritis of the ankle, multiple
4 ankle surgeries, and peripheral neuropathy. Patient A presented to Respondent approximately
5 once a month, or every other month from on or about September 1, 2011, through on or about
6 August 7, 2018, for routine health care for his chronic medical problems, including refills for his
7 Norco and Xanax medications.

8 24. Respondent's medical records consistently reflect similar and at times identical
9 verbiage in the history of present illness section when describing Patient A's ankle pain.
10 Respondent consistently characterized Patient A's ankle pain as "constant and severe; aggravated
11 with weight bearing; denies ankle instability, numbness, swelling and weakness."

12 25. The only aspect Respondent documented of Patient A's musculoskeletal condition
13 related to his ankle is "no edema or significant varicosities, gait: affected by limp." Further,
14 while Respondent noted that Patient A was sent for diagnostic imaging studies for his chronic
15 ankle issues, and referred to an orthopedic specialist in or around 2014, Respondent failed to
16 document make any attempts to decrease or otherwise prescribe any non-controlled substances
17 for Patient A. There was insufficient basis documented to support the ongoing prescribing of
18 Norco and Xanax for Patient A.

19 26. Respondent's records for Patient A variously reflect inconsistencies or lack specific
20 details. For example, in the progress note for a visit on or about July 7, 2015, Patient A was
21 noted to have presented for anxiety and for refills of Norco and Xanax. The history of present
22 illness discusses Patient A's anxiety. However, in the review of systems portion of the progress
23 note, under "psychiatric" the patient was noted as "negative for anxiety and depression."

24 27. From on or about September of 2012, through on or about August of 2018,
25 Respondent failed to document a specific treatment plan and objectives with discussion of
26 potential side effects of continued prescribing of controlled substances and documentation of

1 periodic review of the treatment plan based on a clearly documented, problem specific focused
2 history and physical examination which did not have documented inconsistencies for Patient A.

3 **CIRCUMSTANCES RELATED TO PATIENT B**

4 28. Patient B was a 46-year-old female, with a history of chronic pain syndrome,
5 acquired trigger finger, and cervicalgia. From the period of on or about October of 2012, through
6 on or about January of 2019, Patient B presented to Respondent approximately once a month and
7 he consistently prescribed Methadone HCl for Patient B.

8 29. Respondent utilized similar and at times identical verbiage in the history of present
9 illness section when describing Patient B's shoulder pain. Respondent consistently characterized
10 her pain as "moderate in severity, constant, dull and aching and relieved with Methadone and
11 Naprosyn; aggravated with weight bearing; discomfort increased with repetitive motion . . ."

12 30. Additionally, Respondent continuously documented the musculoskeletal portion of
13 the physical examination as "tone and strength 5/5 L, 4/5 R biceps" and for the neurological
14 portion "sensation, hypoesthesia in the bilateral median nerve distribution." Respondent did not
15 clearly document attempts to taper or decrease the prescribed controlled substances for Patient B.
16 There was insufficient basis documented to support Respondent's ongoing prescribing of
17 Methadone for Patient B. Respondent's medical records for Patient B from on or about October
18 of 2012, to on or about January of 2019, do not contain documentation of any treatment plans, nor
19 did Respondent have and document any clear plan or objectives with discussion of potential side
20 effects for the ongoing prescribing of controlled substances for Patient B. Despite this,
21 Respondent repeatedly refilled Patient B's Methadone prescription.

22 **CIRCUMSTANCES RELATED TO PATIENT C**

23 31. Patient C is a male with a history of spinal stenosis, COPD, chronic pain syndrome,
24 colon cancer, osteoporosis, generalized anxiety disorder, lumbar region radiating pain (sciatica),
25 gout, and chronic kidney disease. Respondent saw Patient C approximately monthly and
26 consistently prescribed Alprazolam, hydrocodone, and oxycodone for Patient C from on or about
27 February 12, 2018, through on or about February 3, 2019.

28 ///

1 32. Respondent noted consistently similar, if not identical verbiage in the history of
2 present illness section when describing Patient C's chronic pain conditions at his visits.
3 Respondent's records for Patient C also contain inconsistencies of the documentation within the
4 progress notes. For example, as to Patient C's visit on or about April 4, 2019, Respondent
5 documented that Patient C presented with worsening symptoms of spinal stenosis in the lumbar
6 region. He was noted as complaining of stiffness and paravertebral muscle spasm with reports of
7 constant pain. However, Respondent documented in the musculoskeletal section that Patient C
8 was negative for arthralgias, joint stiffness, and myalgias. Respondent did not clearly document a
9 specific and focused examination of Patient C's spine despite the fact that the patient returned for
10 controlled substances for management of lumbar pain and spinal stenosis and the neurological
11 examination was merely noted as "grossly intact."

12 33. Further, Respondent failed to clearly document any attempts to decrease Patient C's
13 controlled substances or attempts to prescribe non-controlled substances for Patient C. There was
14 insufficient documentation by Respondent to support the ongoing prescribing of controlled
15 substances to Patient C.

16 34. From in or about February of 2012, through in or about February of 2019,
17 documentation in the plan of care for Patient C noted his prescribed controlled substances were
18 refilled. However, there is no documentation of any treatment plans, nor did Respondent
19 document any clear plan or objectives with discussion of potential side effects for the ongoing
20 prescribing of controlled substances for Patient C. Respondent's records lacked medical
21 indication for the controlled medications prescribed to Patient C over a period of approximately
22 seven years.

23 **CIRCUMSTANCES RELATED TO PATIENT D**

24 35. Patient D was a male patient with a medical history that included low back pain,
25 generalized anxiety disorder, lumbar disc disease, chronic pain syndrome, and major depressive
26 disorder. Respondent consistently prescribed Oxycodone, Clonazepam, Narcan, and Duragesic
27 transdermal patches for Patient D from in or about February of 2015, through in or about 2019.

28 ///

1 Though Respondent saw Patient D occasionally in or about 2015, 2016, and 2017, he saw Patient
2 D at least monthly in or about 2018 and 2019.

3 36. Throughout those years, Respondent repeatedly noted consistently similar, if not
4 identical verbiage in the history of present illness section when describing Patient D's chronic
5 pain condition. Respondent's documentation contains inconsistencies. On or about February 7,
6 2019, Respondent noted Patient D presented with evaluation for low back pain with associated
7 symptoms of "stiffness, radicular right leg pain, and sharp pain going down the leg." However,
8 in the review of systems section, in the musculoskeletal section, Patient D was noted as "negative
9 for arthralgias, joint stiffness, and myalgias." Additionally, Respondent did not consistently
10 document a specific and focused examination of Patient D's spine despite the fact that he was
11 returning for a medical visit for controlled substances for management of the pain in his lower
12 back. Respondent documented on the musculoskeletal portion of the physical examination of this
13 visit "grossly normal tone and muscle strength," but there is no documentation that Respondent
14 performed a neurological examination.

15 37. On or about January 16, 2019, Respondent's progress note indicated that Patient D
16 presented for treatment of anxiety, which had increased. Yet in the review of systems section of
17 the progress note, Respondent documented that Patient D was "negative for anxiety and
18 depression." Respondent failed to attempt to decrease his prescribing of controlled substances for
19 Patient D. Respondent's records lacked sufficient documentation to support ongoing prescribing
20 of controlled substances to Patient D.

21 38. From in or about February of 2015, through in or about March of 2019,
22 documentation in the plan of care for Patient D noted his prescribed controlled substances were
23 refilled. However, there is no documentation of any treatment plans, nor did Respondent
24 document any clear plan or objectives with discussion of potential side effects for the ongoing
25 prescribing of controlled substances for Patient D. Respondent's records lacked documented
26 indication for the controlled medications prescribed for Patient D over a period of approximately
27 four years.

28 ///

1 **CIRCUMSTANCES RELATED TO PATIENT E**

2 39. Patient E was a female patient with a medical history that included hypertension,
3 morbid obesity, spinal stenosis, low back pain, and generalized muscle weakness. Respondent
4 consistently prescribed Methadone and oxycodone for Patient E from in or about October of
5 2012, through in or about July of 2019. During this period, Patient E presented to Respondent
6 approximately once a month.

7 40. Through those years, Respondent repeatedly noted consistently similar, if not
8 identical verbiage in the history of present illness section when describing Patient E's chronic
9 pain condition. Additionally, Respondent's documentation contains inconsistencies. On or about
10 June 26, 2019, Respondent documented that Patient E presented with low back pain with
11 associated stiffness, radicular leg pain, numbness in the right buttock, weakness in the upper legs,
12 and right lower leg swelling. However, in the review of systems section of the progress note,
13 Respondent documented in the musculoskeletal section that the patient was negative for
14 arthralgias, joint stiffness, and myalgias and was negative in the neurological section for
15 weakness and gait disturbance. Additionally, Respondent failed to consistently document a
16 specific and focused examination of the patient's lumbar spine and lower extremities in spite of
17 the fact that she was returning for controlled substances for management of low back pain.
18 Respondent failed to document a focused examination of the lumbar region, though he
19 documented under the musculoskeletal examination that the patient had normal gait with grossly
20 normal tone and muscle strength. Further, Respondent failed to document any attempts to
21 decrease Patient E's controlled substance prescriptions or attempt to prescribe any non-controlled
22 substances for Patient E. There was insufficient documentation by Respondent to support the
23 ongoing prescribing of controlled substances to Patient E.

24 41. From in or about October of 2012, through in or about July of 2019, documentation in
25 the plan of care for Patient E noted her prescribed controlled substances were refilled. However,
26 there is no documentation of any specific treatment plan, nor did Respondent have and document
27 any clear plan or objectives with discussion of potential side effects for the ongoing prescribing of

1 controlled substances for Patient E. Respondent's records lacked medical indication for the
2 controlled substances prescribed for Patient E over approximately six years.

3 **FIRST CAUSE FOR DISCIPLINE**

4 **(Repeated Negligent Acts)**

5 42. Respondent has subjected his Physician's and Surgeon's Certificate No. G 21038, to
6 disciplinary action under sections 2227 and 2234, as defined by section 2234, subdivision (c), in
7 that he engaged in repeated acts of negligence in his documentation practices as to Patient A,
8 Patient B, Patient C, Patient D, and Patient E. The circumstances are set forth in paragraphs 22
9 through 41, above, which are incorporated here by reference as if fully set forth.

10 43. The standard of care requires a medical history and physical exam, which includes an
11 assessment of the patient's pain, including physical and psychological status and function;
12 substance abuse history; history of prior pain treatments and assessment of any other underlying
13 or co-existing conditions. Finally, it should include documentation of recognized medical
14 indications for the use of controlled substances.

15 44. Regarding Patient A, Respondent's documentation of consistently similar if not
16 identical verbiage in the history of present illness, and the inconsistencies in the medical records
17 constitute negligence. Respondent's lack of sufficient documentation in the medical records to
18 support the ongoing prescribing of Norco and Xanax to Patient A over a period of multiple years
19 constitutes negligence.

20 45. Regarding Patient B, Respondent's documentation of consistently similar if not
21 identical verbiage in the history of present illness constitute negligence. Respondent's lack of
22 sufficient documentation in the medical records to support the ongoing prescribing of a controlled
23 substance to Patient B over a period of multiple years constitutes negligence.

24 46. Regarding Patient C, Respondent's documentation of consistently similar if not
25 identical verbiage in the history of present illness constitute negligence. Respondent's lack of
26 sufficient documentation in the medical records to support the ongoing prescribing of controlled
27 substances to Patient C over a period of multiple years constitutes negligence.

28 ///

1 47. Regarding Patient D, Respondent's documentation of consistently similar if not
2 identical verbiage in the history of present illness, and the inconsistencies in the medical records
3 constitute negligence. Respondent's lack of sufficient documentation in the medical records to
4 support the ongoing prescribing of controlled substances to Patient D over a period of multiple
5 years constitutes negligence.

6 48. Regarding Patient E, Respondent's documentation of consistently similar if not
7 identical verbiage in the history of present illness, and the inconsistencies in the medical records
8 constitute negligence. Respondent's lack of sufficient documentation in the medical records to
9 support the ongoing prescribing of controlled substances to Patient E over a period of multiple
10 years constitutes negligence.

11 49. The standard of care requires the medical records contain stated objectives that may
12 include relief of pain or relief of the medical condition requiring controlled substances and/or
13 improved physical or psychological function or ability to perform certain tasks or activities of
14 daily living. This should also include any plans for further diagnostic evaluations and treatments,
15 such as rehabilitation programs.

16 50. Respondent's failure to document a specific treatment plan for Patient A constitutes
17 negligence. Respondent's lack of documentation of a specific treatment plan, aside from refilling
18 of controlled substances, in Patient A's records from in or about September of 2011, through in or
19 about August of 2018, constitutes negligence.

20 51. Respondent's failure to document a specific treatment plan for Patient B constitutes
21 negligence. Respondent's lack of documentation of a specific treatment plan, aside from refilling
22 of controlled substances, in Patient B's records from in or about October of 2012, through in or
23 about January of 2019, constitutes negligence.

24 52. Respondent's failure to document a specific treatment plan for Patient C constitutes
25 negligence. Respondent's lack of documentation of a specific treatment plan, aside from refilling
26 of controlled substances, in Patient C's records from in or about February of 2018, through in or
27 about February of 2019, constitutes negligence.

28 53. Respondent's failure to document a specific treatment plan for Patient D constitutes

1 negligence. Respondent's lack of documentation of a specific treatment plan, aside from refilling
2 of controlled substances, in Patient D's records from in or about February of 2015, through in or
3 about March of 2019, constitutes negligence.

4 54. Respondent's failure to document a specific treatment plan for Patient E constitutes
5 negligence. Respondent's lack of documentation of a specific treatment plan, aside from refilling
6 of controlled substances, in Patient E's records from in or about October of 2021, through in or
7 about July of 2019, constitutes negligence.

8 **SECOND CAUSE FOR DISCIPLINE**

9 **(Failure to Maintain Adequate Medical Records)**

10 55. Respondent has further subjected his Physician's and Surgeon's Certificate No. G
11 21038 to disciplinary action under sections 2227 and 2234, as defined by section 2266, in that he
12 failed to maintain adequate and accurate medical records in his care and treatment of Patient A,
13 Patient B, Patient C, Patient D, and Patient E. The circumstances are set forth in paragraphs 22
14 through 41, above, which are incorporated here by reference as if fully set forth.

15 **PRAYER**

16 WHEREFORE, Complainant requests that a hearing be held on the matters herein alleged,
17 and that following the hearing, the Medical Board of California issue a decision:

- 18 1. Revoking or suspending Physician's and Surgeon's Certificate Number G 21038,
19 issued to Eric Colburn Disbrow, M.D.;
- 20 2. Revoking, suspending or denying approval of Eric Colburn Disbrow, M.D.'s
21 authority to supervise physician assistants and advanced practice nurses;
- 22 3. Ordering Eric Colburn Disbrow, M.D., to pay the Board the reasonable costs of the
23 enforcement of this case incurred beginning on January 1, 2022, and if placed on probation, to
24 pay the Board the costs of probation monitoring; and
