 Case No. 18HM08176, David Lee Haller, M.D. (Respondent) was found guilty by a jury of two
 (2) separate misdemeanor counts of violating Penal Code section 647.6, subdivision (a)(1)
 (Annoying and/or Molesting a Minor).
- 2. On or about October 14, 2022, Respondent was sentenced to the following: 1) serve 365 days in county jail; 2) register as a sex offender pursuant to Penal Code section 290 (the court specifically found that Respondent committed the offenses as a result of sexual compulsion or for the purposes of sexual gratification); 3) formal probation; 4) do not associate with minors or frequent places where minors congregate, including schools, parks, amusements parks, concerts, playgrounds, swimming pools, and arcades; 5) do not use or possess any type of photographic equipment without prior written permission of the probation officer; 6) do not contact, either directly or indirectly, either victim (protective order in effect for a period of 10 years); 7) do not go within 100 yards of either victim; 8) do not date anyone who has children under 18 years old without prior written permission of the probation officer; 9) do not own, use, or possess any type of child erotica (pedophilic paraphernalia) or any illustrated materials depicting unclothed children; 10) submit to continuous electronic/GPS monitoring; 11) do not subscribe or have access to any form of online internet service without prior written permission of the probation officer; 12) do not use, own, or possess any type of sexually explicit movies, videos, materials, or devices; and 13) standard terms and conditions of probation.


